1. Reference is made to the Station's inquiry in reference regarding the information contained on a Headquarters index card referring to HMA-19253. The original of this document was reviewed at Headquarters and there were no notations on page 100 of the original document where Subject's name appeared, which contained the biographic and address information contained on the index card. What happened was that during the process of name tracing Subject (presumably in connection with the RID disstination mentioned in Paragraph #2), the Headquarters tracer identified the Subject mentioned in HMA-19253 as being identical with the person of the same name born 23 January 1934, etc., so had the further identifying information added to the RI card to assist the next tracer. What the Station received was a corrected card.

2. In view of the evaluation placed on the sources of LIKAYAE-S's information in Paragraph #4, that information is not being disseminated to COMNAV. The information from HMA-19253, showing Subject's friendship with the Czech however had already been disseminated by RID to COMNAV in February 1963.
