FRENCH ENGINEER CITED BY DEGRIP IN 26 JULY CONTACT REPORT AS PERSON WHO MIGHT BE WILLING COOPERATE IN ATTEMPT SABOTAGE HAVANA TUNNELS IS UNDOUBTEDLY IDEN WHO SUPERVISOR LITAMIL-13 AND CONTACT LITAMIL-2. PER MEXI 2008 AND MEXI 2931 (DTC 02) IDEN VERY COOPERATIVE AT THAT TIME AND SUGGESTED PLAN TO SABOTAGE MATAZAS POWER PLANT. LEFT FOR PARIS 22 DEC.

2. REQUEST QUERY LITAMIL-2 IF IDEN POSSIBLY NOW MEXICO. IN VIEW PRIORITY INTEREST IN DENIAL OR SABOTAGE ELECTRIC POWER EQUIPMENT BEING SOLD CUBA BY LITAMIL-13, IT POSSIBLE IDEN MAY BE ABLE MAKE USEFUL CONTRIBUTION REBARK EFFORTS.

3. FCA END BEEN GRANTED JAN 63 FOR PARI STATION USE BUT CANCELLED MAY 63.
