SC - 07966-63 E. MAYA, which is believed possibly to be located in Mexico City, DR-828-63 has been inactive for approximately six months. In this case, there was a previous lengthy interruption in traffic. Nothing about this agent and probably will not be able to be investigated unless messages to him reappear on the air. Information is desired to assist in his identification. Mexico aspects to our knowledge.

F. DELIRAN, the location of whom is unknown, was the addressee of a message in late June 1963 after an interval of over seven months. Contents of the earlier traffic indicate that DELIRAN was to have an accommodation in Mexico City.

G. JULIO. Two messages only, dated January 1963 were transmitted to this agent. Contents of one of the messages indicates that he is located in one of the Central American countries.

7. Agents and agent complexes under joint investigation by the FBRUMEN Division and ODENVY (or by ODENVY alone) are detailed briefly below. As you are well aware from the recent SERAFIN report, these too have their Mexico aspects.

24 A. AMAPOLA, with outstation located in the Miami area has for its main objective the penetration of KUBARK and exile operations directed against FBRUMEN. One important agent, possibly the PA, has been identified by ODENVY and is a naturalized U.S. citizen of Cuban birth. ODENVY is currently reading his [S/W] messages; and KUBARK is now interrogating a WAVE asset who has an unexplained connection with the agent. Another WAVE asset who has had contact with the agent, has been interrogated and found to be clean. A third WAVE asset in contact with the agent, has been turned over to ODENVY for possible use against the agent.

B. SERAFIN, with outstation located in Puerto Rico, has been inactive since mid-June 1963 when the principal agent was called to Cuba apparently as a result of discovering a surveillance. ODENVY could not apprehend the agent who is a U.S. citizen and there was insufficient evidence to arrest him. The agent had several contacts and/or supporters, presumably still in Puerto Rico; and in addition, had contacts in New York City. The main objective was to penetrate and penetrate the operations against Cuba. Mexico aspects to our knowledge.
