1. Forwarded as Attachment One under separate cover are reports prepared by Wallace B. ROWTON on the activities of LIRING-3, dated 9, 13, 22, 23, 25, 26 and 27 May 1967. Forwarded as Attachment Two, also under separate cover, are photocopies of correspondence exchanged between LIRING-3 in Mexico City and Pan FISPIJO in Havana. Forwarded as Attachment Three herewith, is a pamphlet obtained by LIRING-3 which contains the text of the message allegedly sent the Tri-Continental organization by Ernesto "Che" GUEVARA.

2. There is little question that LIRING-3 must often ask himself just where his association with ROWTON is taking him and must speculate about just what ROWTON is after. There are obviously times when, left to conjectures and suppositions, LIRING-3 must feel like "quitting." Yet, the ascendancy gradually developed by ROWTON over LIRING-3 has reached the point where LIRING-3 is unwilling to go back to the drab, uninteresting life he lived before meeting ROWTON. The result of LIRING-3's "second thoughts" has up to now been a desire, in the end, to collaborate even more closely with ROWTON. ROWTON's report dated 13 May, and more particularly, LIRING-3's scribble attached to that report, give an indication of the confusion which exists in LIRING-3's mind as a result of the contacts he maintains at ROWTON's urging with the Cubans, Guatemalan rebels, and various shades of Mexican and Central American leftists.

In addition LIRING-3, a professional artist, finds himself involved in the development of a commercial venture, an undertaking for which he is ill equipped. This ~~other~~ shortcoming requires very close guidance by RWTCH and, in turn, makes LIRING-3 even more dependant on his case officer. Thus, while LIRING-3 occasionally thinks of returning to painting and giving art lessons and develops qualms about taking money from RWTCH for what he considers to be little result, LIRING-3 keeps involving himself deeper and deeper in activities of interest to RWTCH.

3. The above does not mean that LIRING-3's activities should not be subjected to every operational control possible, on the contrary. LIRING-3's story concerning the manner in which birth certificates can be obtained in Northern Mexico to secure valid Mexican passports continues, for example, to be suspect. It now appears, on the other hand, that "GARCIA" of the Guatemalan FAR exists (LIRING-4 talked to him) and that he does not want LIRING-3 to come in contact with other Mexico residents connected with the Guatemalan guerrillas such as the alleged FAR propaganda representative at the UNAM University. LIRING-3 is convinced he can lay on a meeting with GARCIA in advance so that RWTCH can have a look at the Guatemalan. In spite of GARCIA's cautiousness, such a meeting has to take place sooner or later. The Station is ready. It also appears that for reasons as yet unclear, Mexican leftists such as Sergio VALDEZ, Raúl FERENO and others are seeking LIRING-3 and appear to want something from him.

4. RWTCH's recent efforts to develop LIRING-4's potential regarding LIRING and it's staff paid off when LIRING-4 was asked to "fill in" when one of the secretaries in LIRING-9's section had to return home temporarily on sick leave. It already appears that LIRING-4, an experienced hand in LIRING-9's overt business, will be given quite a bit of responsibility in that office. It is hoped that by becoming quasi indispensable she will be asked to remain at LIRING after the return of the person for whom she is "filling in." LIRING-4, while very much in love with her husband, has a mind of her own, a great liking for RWTCH and, according to LIRING-3 himself, an intelligence much superior to his. She is also gifted with Oriental type poise. With LIRING-3's knowledge, RWTCH has started to make small payments to LIRING-4 to provide separate financial incentive and help her pay for furniture and other items she purchased on credit some time ago.

5. The sketch mentioned in the last paragraph of RWTCH's report dated 26 May was retained by this Station. RWTCH used this sketch to discuss with LIRING-4 the layout of LIRING-9's section. The statement made at the end of paragraph 4 of the report dated 27 May is in error. LIRING-9's section has two telephones. What LIRING-4 took for a third phone in the back room of that section is in reality an intercom unit.

6. Headquarters attention is called to paragraphs 3 through 5 of RWTCH's report dated 26 May. The fact that Silvia DURAN had sexual intercourse with Lee Harvey OSWALD on several occasions when the latter was in Mexico City is probably new, but adds little to the OSWALD case. The Mexican police did not report the extent of the DURAN-OSWALD relationship to this Station.

7. The result of Station file checks on VALDEZ and MERINO were indicated in the reference. Those on Narciso and Eugenio CLOUTIER are being forwarded in a dispatch covering LIRING-7's activities. There are no traces on Pau ESTREJO. Silvia DURAN and Teresa FERNANDEZ are well known to Headquarters. Felipe ROMAS Morales is an employee of the Mexico City Cuban-Mexican Cultural Institute.
