2. Mercy MARTINEZ is listed by the Cuban Foreign Ministry as Sub-Director of the Secretariat of the Ministry. Her immediate superior is Juan Nilo *OTERO Rodriguez for whom she signed the letter of Reference A.

3. It is requested that every effort be made to insure that the attachments are handled in such a way as to protect LITAMIL-9 and the LITAINI-2 trash operation from compromise.
