GRACIA TORRES, Amado Antonio

PUYO, Delfin H. - C-35357 - Relative in U.S.

File contains report from another Federal Agency dated January 9, 1961 relating information received from Richard Mier of "The New York Times." Mier telephonically advised a representative of the other Federal Agency on January 7, 1961 that "the New York Times" had received a special delivery letter postmarked New York, N.Y., General Post Office, January 7, 1961, 7:30 P.M.

The letter was purportedly from a member of the Cuban Consulate and informed that the assassination of Delfin H. Puyo had been planned by the Consulate on orders from Havana and that Fidel Castro himself was interested in his death.

Mier advised that Puyo was Secretary-Treasurer of Radio Free Cuba.

A confidential informant advised on January 9, 1961, that one Delfin H. Puyo has offices at 487 Broadway, New York, N.Y. and further stated that Puyo is the former Cuban Ambassador to Canada. He also stated that Puyo has a bad reputation in that it is alleged that he used to carry contraband, including dope, between the United States, Canada and Cuba.

Puyo may or may not be ident to subject's U.S. relative.

ESTRADA PEADO, Enrique - C-24207 - Close Assoc.

Estrada Peado, who is probably ident to subject's close associate, was granted an OA on 5 May 1966. N.D.

HASSIP HASSIQUE, Enrique - C-22492 - Close Assoc.

Hassip Hassique, who is probably ident to subject's close associate, was granted FOA's in 1960 and 1964 and an OA in 1964. N.D.

AGUERO COMTE, Luis - C-244508 - Close Assoc.

Aguero Comte, who is probably ident to subject's close associate, was of operational interest to the Agency in 1961. N.D.

FONTELA ALFONZI, Mario F. - C-22151 - Close Assoc.

Fontera Alfonzi, who is probably ident to subject's close associate, was of operational interest to this Agency from 1960 to 1968. N.D.

ESTRADA PEADO, Enrique H. - C-850585 - Close Assoc.

Estrada Peado, who is probably ident to subject's close associate, is of current operational interest. N.D.
