Reference: HRS-W-1326 of 3 September 1957

1. The files of all appropriate Panama and Canal Zone agencies were reviewed for information concerning the Subjects of reference, as requested therein. The only agency with information on Subjects was HYAFFIX, and a verifax copy of that organization's file is forwarded as a separate cover attachment to this dispatch for the information of KUSODA. Information available in Station files was solely that contained in information copies of HYAFFIX reports. Station realizes that the information contained in paragraph 2 of reference was undoubtedly based on these same HYAFFIX reports and therefore does not necessarily constitute confirmation. As will be noted, Subjects have not been a matter of record in files of any local agencies since May 1945.
2. In view of the elapsed time since Subjects were employed in Panama, current investigation was not deemed feasible.
3. Headquarters may provide Stations San Jose and Habana with copies of the separate cover HYAFFIX file at its discretion.
