
Dear John:

In addition to its requests of June 20 and June 28, the ARRB will need information on the names, pseudonyms and crypts appearing on the attached brief list in order to prepare for its July 17-18 Board Meeting. As with the previous lists, we would appreciate your sending "clear and convincing" evidence in support of the Agency's recommendation to postpone release, including short descriptions of each crypt, a brief identification of each individual (including what that person was doing for the CIA in 1963-64, whether the name is a true name or a pseudonym), and indications of whether these crypts, operations, and individuals are presently active or inactive. As we have discussed, the Board in particular needs to know, in specific terms, what evidence CIA can provide for those cases where release would endanger personal safety, ongoing intelligence operations, or current foreign relations. To help with your search, we have included document numbers where these names and crypts are found.

We are also enclosing copies of the first pages of two documents for which your staff needed further identification.



SUMMARY OF INFORMATION WITHIN FILE:

There are three files on subject who was recruited in March 1955 as a member of the Mexico City Station unilateral surveillance team. By late 1956 he had become the P/A in charge of the surveillance team and in addition was in charge of photo surveillance of the soviet mission, including processing the film. From the time of his marriage in December 1958, and for the next 10 years, his wife assisted him as a part-time support asset. Over the years, subject performed additional duties such as giving English lessons, serving as LP keeper, transcriber/translator of an audio operation, involvement in ops against the Cuban mission and Cuban exile groups, general ops support, and spotting and assessment. The last station contact with him was in May 1971.
