1. Reference is made to the report concerning the above  
subject made by telephone to Mr. S.J. Papich at 0930 on 17 April  
1968. Following is a full account of the investigation made in  
this case:


A. On 16 April 1968 a United States ~~B-G~~  
~~B-G~~ in ~~B-G~~ reported that one  
~~C~~, who bore a general physical  
resemblance to the description given of the suspected  
assassin of Dr. Martin Luther King, Jr. had arrived  
in ~~D~~ about 15 April 1968 and requested a position  
~~C~~ became  
agitated when asked for a contact address in ~~G~~  
and refused to divulge his ~~C~~ residence. The  
~~C~~ described ~~C~~  
as 5' 10" tall, 155 pounds, with brown hair, a receding  
hairline on both sides, and a not very prominent scar  
two and one-half inches long traversing the center  
forehead, his most outstanding characteristic being a  
disconcerting, idiotic grin resembling a constant  
grimace. According to ~~C~~ documents and state-  
ments, he was born 8 April 1937, applied for ~~G~~  
~~C~~ California, 16 June 1964 and  
registered there as a ~~C~~  
~~C~~ on 21 February 1968 but never ~~C~~






