1. UPI SPECULATES THAT ADAM CLAYTON POWELL MAY HAVE PLANNED HOLD BLACK POWER CONFERENCE ON 25 FEBRUARY, BUT NO ONE SHOWED UP. Bimini Commissioner SAID CONFERENCE HAD BEEN SCHEDULED AT HOTEL ON NORTH Bimini AND THAT POLICE HAD BEEN ALERTED ALTHOUGH TROUBLE WAS NOT ANTICIPATED. Bimini WAS CHOSEN AS SITE OF CONFERENCE, ACCORDING TO UPI'S SOURCE, BECAUSE IT WAS EASIER TO DO IT THERE THAN IN THE UNITED STATES.

2. UPI REPORT DID NOT MENTION THAT DR. MARTIN LUTHER KING WAS EXPECTED TO ATTEND, HOWEVER IT DID CARRY THE OTHER NAMES MENTIONED TO REF AS THOSE INVITED.
