1. IN TALK WITH LOCAL CUBAN EXILES ARTIME EXPRESSED COMPLETE SATISFACTION HIS NEGOTIATIONS WITH PRESIDENT RENE SCHICK AND THE SOMOZAS. HE APPARENTLY GOT PROMISE OF FULL COOPERATION IN FUTURE PBRUMEN OPS.
2. ARTIME SAID HIS TALKS WITH PRESIDENT ORLICH AND JOSE FIGUEREU HAD ALSO BEEN FRUITFUL. HE FELT EXISTING POLITICAL DIFFERENCES BETWEEN COSTA RICA AND NICARAGUA WOULD ADVERSELY AFFECT COOPERATION IN PBRUMEN OPS UNLESS MATTER IS HANDLED VERY TACTFULLY.
3. ARTIME LEFT SJOS FOR PACY BY AIR ABOUT NOON ON 29 MAY.
4. SJOS HOPES HAVE ADDITIONAL INFO ARTIME VISIT HERE AND WILL CABLE SIGNIFICANT DATA AS ACQUIRED.
5. SOURCE ⁰² [HULAKE-1 (C), EVAL-3. NO LOCAL DIST BUT NO OBJECTION TO HQS DISSEM.
