READINGS ARE DEFINITIVE. APPRAISAL OF CONTENT IS TENTATIVE.

1. ON 15 APRIL 1962 A GROUP OF NEO-COMMUNISTS HAD LUNCH WITH DR. GUILLERMO ALONSO PUJOL AT VICTOR BORDON'S HOME. THE LUNCHEON WAS ALSO ATTENDED BY THE TWO SONS OF ALONSO PUJOL, ONE OF WHOM WAS A PLAYA GIRON PRISONER BEING RANSOMED BY THE FATHER. DURING THE COURSE OF THE LUNCHEON ALONSO PUJOL ATTACKED THE "YANQUIS" SAYING THAT THEY WERE RESPONSIBLE FOR ENSLAVING THE BOYS IN THE ABSURD INVASION AT PLAYA GIRON. HE CONTINUED BY SAYING THAT HE WAS ANTI-YANKEE AND THEREFORE LIVED IN PANAMA, AND THAT IN HIS OPINION THE YANKEES WOULD NOT COME AND THE STORIES OF (TRAINING) CAMPS WAS MERELY A TALL TALE. ALONSO

ALONSO ATTACKED ANTONIO VARGAS FOR CRITICIZING THE PURCHASE OF THE INVADERS.

2. ALONSO'S SON TRIED TO DEFEND VARGAS, BUT HIS FATHER SHUT HIM UP.

3. ALONSO ALSO REPORTED THAT SERGIO CAREO HAD COLLECTED SUFFICIENT MONEY TO RANSOM HIS SON INDEPENDENTLY, AND THAT HIS SON HAD ALREADY BEEN NOTIFIED.

4. ALONSO PUJOL HAD VISITED PRAGUE, BUT WAS NOT ALLOWED TO ENTER THE SOVIET UNION AS THE COMMUNISTS ARE AFRAID OF HIM. FIDEL CASTRO HAS BEEN HEARD TO COMMENT THAT HE IS USING ALONSO FOR THE PURPOSE OF DIVIDING THE OPPOSITION. A LEADING CUBAN GOVERNMENT OFFICIAL FEELS THAT FOR THE TIME BEING FIDEL IS ALLOWING HIMSELF TO BE ADVISED BY ALONSO.
