HOWEVER, WHEN QUEVEDO (PORTION GARBLED) [S]⁰² THAT BOHEMIA HAD PREVIOUSLY OPERATED ENTIRELY ON BASIS ODYOKE SUBSIDY WHICH WAS WITHDRAWN MAKING IT NECESSARY BOHEMIA SCRATCH OUT NEW FINANCIAL BASE, [S]⁰² WONDERED IF HAD DONE RIGHT THING. UNEASY ABOUT SUPPORTING PUBLICATION WHICH MAY HAVE BEEN DROPPED BY ODYOKE FOR POLITICAL POLICY REASON.
