On 26 November 1961, the wife of Rodrigo STURIAS informed MESSAGE-3 that a sister of (LIBLUX) has received a letter sent by him from Mexico in which he stated he wished to clarify doubts regarding AMUPAS-1. According to (LIBLUX), he had checked with persons from Cuba and had been told that STURIAS enjoyed the complete confidence of the Cubans; that she had performed magnificent services in behalf of the Cuban revolution; and that she should be considered to be above suspicion.</p> <p>3. Prior to the arrival of AMUPAS-1 in Guatemala, the Partido Guatemalteco del Trabajo (PGT--Communist Party of Guatemala) was advised of her coming and word was passed through PGT channels that in Cuba there were serious doubts as to the loyalty of AMUPAS-1 and that possibly she was an agent of the U.S. Government. The PGT leadership advised that PGT elements in Mexico had taken AMUPAS-1 completely into their confidence, disregarding the suspicions of her hold in Cuba, and that locally she was to be given courteous and polite treatment but PGT security was not to be jeopardized.</p> <p style="text-align: right;">Stanley B.
