ON MARCH 1 + 2 SOURCE'S FAMILY PERTINING
(JEWELRY + CAR) WERE SEARCHED BY READING
WARRANT BECAUSE OF SOURCE'S FAMILY (MURKIN
+ PATRICK) CURRENTLY LIT ON CLOUD. SOURCE'S
OWN APT. + CAR AND FARM WERE ANT-Searched
AT THE TIME. ON MARCH 3 AT 13.30HRS.
G2 PICKED UP SOURCE IN HIS APT. AND
TOOK HIM TO G2 FOR "EXPLANATION"
WITHOUT FURTHER EXPLANATION AND
ROTUNALLY HELD UNDER ARREST + IMMINENTLY
AS FROM TIME HE WAS PICKED UP IN HIS APARTMENT
TIME HE WAS RELEASED MARCH 6 AT 14.00HRS.
SOURCE WENT UNDER THE IMPOSITION IT WAS AN
INVESTIGATION REGARDING SOURCE'S FAMILY MEMBERS
AND WHETHER TO CONFISCATE FAMILY PROPERTY.
EXCEPT THE BOSTONFIRE COMPANY CONTACTS NO OTHER
CONTACTS KNEW HOW TO MAKE IDENTIFICATION OR
MEASUREMENTS OR HOW TO REACH HIM, THOUGH HEAD
SOURCE WAS IN PIGENT HIS OPERATIONS AND NOT
WERE NOT INVOLVED. BECAUSE OF INCriminating
DOCUMENTS IN SOURCE'S APT. AT THE TIME OF ARREST
IN WHICH GROUP WAS WALKING AND PROPHETIC FOR
NOT AVAILABILITY CONSPIRACY, AND IN AN ATTEMPT TO HONEY
GROUP SOURCE CORPORAELY WENT TO G2 IN HIS OWN CAR
FOR GROUP TO TRUCK PARKED IN G2 PARKING LOT AND
PURPOSELY SOURCE LEFT BEHIND HIS INJECTION
NIP (SOURCE IS DIABETIC AND REQUIRES DAILY INJECTIONS
IN PECTOMY) TO GO HOME TO SOURCE + RETURN
TO THE APT. AND/OR MADE CONSULTATIONS
IN CONTACTING A DOCTOR OR TAKEN TO A HOSPITAL.
NO OTHER MEMBERS OF THE GROUP WERE IN THE APT.
AT TIME OF ARREST AND THE APT. NOT SOURCE WHICH
SEARCHED THE ARRESTING G2 OFFICERS, TWO WITH
MACHINED GUNS, WERE CONSTANTLY BESIDE SOURCE.

while getting dressed and did not allow source to call or send any radio signal although source managed to make off and his detention in the bldg. was told the policeman he was being taken to G-2 office unexplained glorification, giving source motor opportunity to check latest developments. It was not until 3-3-61 at 14.00 hrs that source was interrogated prior to his release and explained that bombs and/or explosive materials & detonators were voluntarily reported by source's father's farm caretaker to G-2 on 3-3-61 A.M., and subsequently the arrest of source, farm caretaker and farm neighbor's night watchman until further investigation. The bombs and/or materials were found in the grass right by the farm's fence on main central highway and by the time source was interrogated G-2 officers were convinced materials were obviously thrown over the fence by unidentified persons and the three under arrest for investigation were innocent and therefore released, however source, as everyone taken to G-2, was thoroughly fingerprinted, photographed and registered in their files with eight prints on each, showing full distribution. Source's good conduct and fast talk thoroughly convinced them of source's prorevolutionary spirit and intention to cooperate with revolutionary government to supply needed electrical equipment for present industrialization program sending some from outside US against U.S. embassy to China. G-2 officers actually excused their need to arrest and investigate source and requested from source

BEEN PLACED IN STORAGE AND NOT AVAILABLE
AT THE ENDING HOUR TIME OF RELEASE, WHERE
SOURCE CHARGED CLOTHES AND INCLUDED MULTU-
MINATING DOCUMENTS LEFT BEHIND BY GRUPO
WHEN THEY FINALLY EVACUATED SOURCE'S APT.
TO COLLECT DOCUMENTS KNOWN BY THEM
THEIR, AND THEN SOURCE LEFT THROUGH A

THOROUGHLY BELIEVES THAT OPERATIONS
AND NET ARE CLEAR AND THAT SOURCE'S IN-
VESTIGATION AND ARREST BY G2 WAS PURELY
COINCIDENTIAL. SOURCE SUGGESTS FOR ACTI-
VITIES OF GROUP TO CONTINUE AS CUR-
RENT BUT WITH SOURCE COMPLETELY
DISCONNECTED FROM NET AND OPERA-
TIONS UNTIL CERTAIN THAT SOURCE IS
NOT UNDER POSSIBLE SURVEILLANCE
AND/OR POSSIBLE FOLLOWUP CHECKING
BY G2 AFTER SOME TIME. GROUP CAN
TAKE OVER SOURCE'S OPERATIONS AND
CONTACTS WHILE SOURCE DEDICATES HIM-
SELF EXCLUSIVELY AND ACTIVELY TO HIS
COVER UP ACTIVITIES AND TO STRENGTH HIS
COVER AS TOLD TO G2 OFFICERS.
