ON MARCH 1 + 2 SOURCE'S FAMILY PROPERTIES
 (APARTMENTS + CAR) WERE SEARCHED BY REVIEWS
 AGENTS BECAUSE OF SOURCE'S FAMILY INFLUENCE
 + PATRIOTIC CURRENTLY OUT OF CUBA. SOURCE'S
 OWN CAR + CAR AND FARM WERE NOT SEARCHED
 AT THE TIME. ON MARCH 3 AT 13.30 HRS.
 G2 PICKED UP SOURCE IN HIS APT AND
 TOOK HIM TO G2 FOR "CLARIFICATION"
 WITHOUT FURTHER EXPLANATION AND
 ACTUALLY HELD UNDER ARREST + ANTI-COMMUNISM
 IN FACT TIME HE WAS PICKED UP IN HIS APT. UNTIL
 TIME OF HIS RELEASE MAIL AT 14.00 HRS.
 SOURCE WENT UNDER THE IMPRESSION IT WAS AN
 INVESTIGATION REGARDING SOURCE'S FAMILY INFLUENCE
 AND NOT TO CONFISCATE FAMILY PROPERTY.
 EXCEPT FOR BOUTIQUE COMPANY CONTACTS NO OTHER
 CONTACTS NOW AS SOURCE IDENTIFIED THE
 WHEREABOUTS OF HOW TO REACH HIM, THOSE WHO
 SOURCE WAS INVOLVED HIS OPERATIONS AND NET
 WERE NOT INVOLVED, BECAUSE OF INCRIMINATING
 DOCUMENTS IN SOURCE'S APT AT THE TIME OF ARREST
 IN WHICH GROUP WAS WORKING AND PROPOSED FOR
 NET AVAILABLE COURIER, AND IN AN ATTEMPT TO HIDE
 GROUP SOURCE PURPOSELY WENT TO G2 IN HIS OWN CAR
 FOR GROUP TO TRACE PARKED IN G2 PARKING LOT AND
 PURPOSELY SOURCE LEFT BEHIND HIS INJECTION
 KIT (SOURCE IS DIABETIC AND REQUIRES DAILY INSU-
 LIN INJECTIONS) TO BE ABLE TO HIDE + DIS-
 TERN TO THE NET AND/OR MAKE OPPORTUNITIES
 IN CONTACTING A DOCTOR OR TRIP TO A HOSPITAL.
 NO OTHER MEMBERS OF THE GROUP WERE IN THE APT
 AT TIME OF ARREST AND THE APT WAS SEARCHED
 SEARCHED THE ARRESTING G2 OFFICERS, TWO WITH
 MACHINE GUNS, WERE CONSTANTLY BESIDE SOURCE

WHILE GETTING DRESS, AND DID NOT ALLOW SOURCE
 TO CALL OR LEAVE ANY VIBRA SIGNAL ALTHOUGH
 SOURCE MANAGED TO MAKE OTHERS HIS DETENTION
 IN THE PLDG, AND TOLD THE DECKMAN HIS WAS
 BEING TAKEN TO G-2 FOR UNEXPLAINED
 CLARIFICATION, GIVING DRAMP NOTION OF INSTA-
 BILITY TO CHECK LATEST DEVELOPMENTS, IT
 WAS NOT UNTIL 3-6-61 AT 14.00 HRS THAT SOURCE
 WAS INTERVIEWED FROM TO HIS RELEASE.
 AND EXPLAINED THAT BOMBS AND/OR EXPLOSIVE
 MATERIALS & DETONATORS WERE VOLUNTARILY
 REPORTED BY SOURCE'S FATHER'S FARM CARE-
 TAKER TO G-2 ON 3-3-61 A.M., AND CONSE-
 QUENTLY THE ARREST OF SOURCE, FARM CARE-
 TAKER AND FARM NEIGHBOR'S NIGHT WATCH-
 MAN UNTIL FURTHER INVESTIGATION THE BOMBS
 AND/OR MATERIALS WERE FOUND ON THE GRASS RIGHT
 BY THE FARM'S FENCE ON MAIN CENTRAL HIGHWAY
 AND BY THE TIME SOURCE WAS INTERVIEWED G-2 OFFI-
 CERS WERE CONVINCED MATERIALS WERE OBVIOUSLY
 THROWN OVER THE FENCE BY UNIDENTIFIED PERSON(S)
 AND THE THREE UNDER ARREST FOR INVESTIGATION
 WERE INNOCENT AND THEREFORE RELEASED, HOWEVER
 SOURCE, AS EVERYTHING TAKEN TO G-2, WAS THOROUGHLY
 FINGERPRINTED, PHOTOGRAPHED AND REGISTERED IN
 THEIR FILES WITH EIGHT COPIES OF EACH, EVIDENCE
 FOR DISTRIBUTION. SOURCE'S GOOD COVER AND HASTY
 TALK THOROUGHLY CONVINCED THEM OF SOURCE'S
 PROREVOLUTIONARY SPIRIT AND INTENTION TO COOP-
 ERATE WITH REVOLUTIONARY GOVERNMENT TO SUPPLY
 NEEDED ELECTRICAL EQUIPMENT FOR PRESENT INDIV-
 IDUALIZATION PROGRAM WHICH SOURCE SAID FROM OUTSIDE
 US AGAINST US. EMPHATIC TO CHAIR. G-2 OFFICERS
 ACTUALLY EXCUSED THEIR NEED TO ARREST AND IN-
 VESTIGATE SOURCE AND REQUESTED FROM WARRD

TO CONTINUE HIS NORMAL ACTIVITIES IN CUBA WITH FULL FREEDOM TO LEAVE & ENTER CUBA. WHILE UNDER ARREST IN DE SOURCE DID NOT TAKE ANY AMBUSHMENT THE FIRST USARS AND MADE BELIEVE HE WAS GOING INTO A PATROL DIRECTION COMPANY BECAUSE OF CASE OF FOOD AND INSULINE FORCING THEM TO TAKE SOURCE TO MILITARY HOSPITAL IN CAMP LIBERTAD (COLUMBIA) AT 24.00 HRS ON 3-4-61 AND THEN TO SOURCE'S APT. AT 11.00 HRS ON 3-5-61 TO PICK UP INSULINE AND INJECTION KIT, AT WHICH OPPORTUNITY SOURCE ENGAGED THE APT AND MET ODEON GARCERAN, THAT DOCUMENTS WERE STILL THERE, AND SOURCE PURPOSELY LEFT TWO LIGHTS ON FOR ANOTHER ATTENTION TO THE CAMP. UPON RELEASE SUBJECT WENT TO APT. IN TATE, HE WAS INSTRUCTED TO PICK UP HIS CAR FOLLOWING DAY A.M. BECAUSE SAME HAD BEEN PLACED IN STORAGE AND NOT AVAILABLE AT THE EVENING HRS TIME OF RELEASE, WHERE SOURCE CHANGED CLOTHES AND PICKED UP MINUTING DOCUMENTS LEFT BEHIND BY CAMP WHEN THEY FINALLY ENTERED SOURCE'S APT. TO COLLECT DOCUMENTS KNOWN BY THEM THERE, AND THEN SOURCE LEFT THROUGH A DIFFERENT ~~W~~ ENTRANCE TO THE BLDG. A APPROACHED A SH TO CONTACT CAMP IMMEDIATELY AFTER TAKING SEVERAL DETOURS AND PATROLS ON THE WAY. SOURCE

THOROUGHLY BELIEVES THAT OPERATIONS
AND NET ARE CLEAR AND THAT SOURCE'S IN-
VESTIGATION AND ARREST BY G2 WAS PURELY
CINCIDENTAL. SOURCE SUGGESTS FOR AC-
TIVITIES OF GROUP TO CONTINUE AS BE-
FORE BUT WITH SOURCE COMPLETELY
DISCONNECTED FROM NET AND OPERA-
TIONS UNTIL CERTAIN THAT SOURCE IS
NOT UNDER POSSIBLE SURVEILLANCE
AND/OR POSSIBLE FOLLOWUP CHECKING
BY G2 AFTER SOMETIME. GROUP CAN
TAKE OVER SOURCE'S OPERATIONS AND
CONTACTS WHILE SOURCE DEDICATES HIM-
SELF EXCLUSIVELY AND ACTIVELY TO HIS
COVER UP ACTIVITIES AND TO STRENGTH HIS
COVER AS TOLD TO G2 OFFICERS.
