- C. MARIA GOMEZ HEAD OF THE "SECCIONAL" OF THE TWO DE AGENTS THAT INTERVIEWED SUBJECT ON HER FORMAL APPLICATION TO LEAVE CUBA.
- D. FNU/ RAMOS A DSE AGENT WHO INTERVIEWED SUBJECT AND SIGNED HIS NAME TO THE HOUSEHOLD INVENTORY FORM AND THE IMMIGRATION SEAL ON BACK OF HER PASSPORT.
- E. MARIA MENDIVER PRESIDENT OF THE COMITE NEXT TO SUBJECT'S HOUSE.
- F. ROBERTO /LNU/ A POLICEMAN FROM THE GUANABOSOM.
 HAVANA STATION WHO ADVISED SUBJECT ON HOW TO CONDUCT HERSELF IN WINNING OVER THE COMITES TO HER SIDE.
- G. AN UNIDENTIFIED DSE AGENT WHO INTERVIEWED SUBJECT AT
- H. AN UNIDENTIFIED FEMALE CLERK BURLOTED BY GUBANA AIR-LINES WHO HANDLED SUBJECT'S RESERVATIONS AND TICKET ARRANGEMENTS AT THE AIRPORT.

- 1. 12 APRIL 1964 AMMUG-1 LEFT CUBA ON THIS DATE, INFORMING SUBJECT THAT HE WAS GCING TO CANADA ON A MISSION FOR THE GOC. HE TOLD HER NOTHING MORE AND SHE HAD NO IDEA AS TO HIS SPECIFIC MISSION.
- 11. CIRCA 30 APRIL 1964 A. A NEIGHBOR, EMILIA CONTINO, TOLD SUBJECT CONFIDENTIALLY THAT A ''G-2'' CAR WITH FIVE MEN INSIDE, HAD PARKED OUT FRONT AND A MAN HAD RAPPED CN HER DOCR TWO DAYS EARLIER /CIRCA 28 APRIL 1964/. WHEN THE NEIGHBORS INFORMED THE ''G-2'' AGENTS THAT SUBJECT SPENT THE DAYS WITH HER MOTHER, THEY ASKED TO SEE THE PRESIDENT OF THE LOCAL ''COMITE DE DEFENSA.''
- B. ALTHOUGH SUBJECT SUSPECTED THE "G-2" VISIT WAS RELATED IN SOME WAY WITH HER HUSBAND, SHE DID NOT KNOW THE DETAILS. SHE DID NOT, HOWEVER, DISCUSS HER HUSBAND WITH THE 'COMITE.'
- CIRCA 12 JUNE 1964 ABOUT TWO MONTHS AFTER HER HUSBAND LEFT, III. CIRCA 12 JUNE 1964 - ABOUT TWO MONTHS AFTER HER HUSBAND LEFT, SUBJECT WAS GIVEN A LETTER BY HER MAILMAN WHICH HAD BEEN OPENED AND CRUDELY RESEALED. NO ATTEMPT WAS MADE TO DISGUISE THE FACT THAT THE LETTER HAD BEEN OPENED. THE LETTER /POSTMARKED IN MEXICO AND ADDRESSED TO HER/ WAS IN HER HUSBAND'S HANDWRITING BUT WAS UNSIGNED. HE SAID HE WAS SORRY FOR THE DECISION HE HAD TAKEN AND ASKED HER TO TELL HER PARENTS THAT HE HAD NOT ABANDONED HER. SHE ANSWERED THE LETTER IMMEDIATELY SENDING IT TO THE RETURN ADDRESS HE GAVE. THE LETTER IMMEDIATELY SENDING IT TO THE LETTER AND MAILED IT IN HAVANA. SUBJECT DISCUSSED RECEIPT OF THE LETTER WITH HER GIRL FRIENDS IN THE APARTMENT BUILDING. NOTABLY EMILIA CONTINO AND EVA FRIENDS IN THE APARTMENT BUILDING, NOTABLY EMILIA CONTINO AND EVA RODRIGUEZ, TELLING THEM THAT HER HUSBAND HAD ABONDONED HER. SHE COMPLAINED TO THEM OF HER ILL FORTUNE.
- IV. CIRCA 28 JUNE 1964 A. SUBJECT STATED THAT SHE WENT THROUGH A TERRIBLE ORDEAL DURING THIS PERIOD AND DID NOT KNOW WHAT TO MAKE OF THE SITUATION. SHE DESCRIBED HERSELF AS A BUNDLE OF NERVES AND BEGAN TO SHOW THE STRAIN.
- B. ABOUT A WEEK AFTER HER HUSBAND'S LETTER ARRIVED, SHE CROSSED PATHS WITH THE 'COMITE' PRESIDENT MARIA MENDIVER WHO ASKED MATTER OF FACTLY HOW SHE WAS AND IF SHE HAD HEARD FROM HER HUSBAND. SUBJECT TOOK THE OCCASION TO RELATE IN AN EMOTIONAL MANNER THAT HER HUSBAND HAD ABONDONED HER, BUT THAT SHE HAD RECEIVED A LETTER FROM HUSBAND HAD ABONDONED HER, BUT THAT SHE HAD RECEIVED A LETTER FROM HIM. /SUBJECT SUSPECTS THAT MARIA HAD HEARD OF THE LETTER FROM HER NEIGHBORS./ SUBJECT CALLED HER HUSBAND ALL SORTS OF NAMES FOR

FOR DESERTING HER AND TRIED TO EVERES PETPY BY STATING THAT HER HUSBAND

HAD BEEN CHEATING ON HER AND HAD ON CCCASION STAYED AWAY AT NIGHT LATER SHOWING UP WITH LIPSTICK ON HIS UNDERCLOTHING. SHE ADDED SHE HAD GONSTOERED A SEPARATION BEFORE THIS INCIDENT. THIS APPROACH APPARENTLY WORKED AS MARTA THEN TOLD HER NOT TO WORRY AND TO LEAD HER OWN LIFE AS HER HUSBAND WAS NOT WORTH WAITING FOR OR WORRYING ABOUT SINCE HE WAS A TRAILOR TO HER AND TO HIS COUNTRY. MARIA SAISHE KNEW HE HAD FLED WHEN THE G-Z CAME LOCKING FOR HER AND ASKED MANY OUTSTRONG ADDITIONS MANY QUESTIONS ABOUT HER. MARIA THEN RELATED THE FOLLOWING QUESTIONS THE 'G-2' HAD POSED AND HER ANSWERS -

G-2 - WHAT KIND OF A PERSON IS SHE?

MARIA - A GOOD DECENT PERSON.

G-2 - HAS SHE CRITICIZED THE GOVERNMENT? MARIA - 140 BE COMMITTING AN INJUSTICE IF 1 SAID SHE WAS. G-2 - DID YOU SEE HER GET IN OR OUT OF STRANGE CARS?

MARIA - NO. G-2 - DOES SHE HAVE STRANGE PERSONS JUNKNOWN PERSONS IN HER HOUSE AS VISITORS?

MARIA - NO.

G-2 - HOW DOES SHE LIVE? MARIA - HER PARENTS SUPPORT HER.

MARIA ADVISED SUBJECT TO LEAD A NORMAL LIFE AND TO GO TO HER MOTHER'S HOUSE EVERY DAY. IF SHE WENT OUT, SHE SHOULD GO WITH HER 'SISTER-IN-LAW' GISELA CONFINI AND SHOULD NOT BE SEEN TALKING WITH STRANGERS AS HER EVERY STEP WAS BEING WATCHED. THEY /THE G-2/ WERE LOOKING FOR THE LEAST EXCUSE TO PLACE HER IN PRISON.

V. END OF JUNE 1964 - A. A MAN IDENTIFYING HIMSELF AS BEING FROM THE 'REFORMA URBANA' CAME TO HER APARTMENT AND TOLD HER THAT HER HUSBAND HAD EXILED HIMSELF. HE SAID THAT THE 'REFORMA URBANA' WAS INITIATING AN INVESTIGATION TO SEE IF SHE HAD LIVED LONG ENOUGH IN THE APARTMENT ONE YEAR. IF NOT, SHE WOULD HAVE TO VACATE THE APARTMENT. HE CHECKED THE CONTRACT AND THE RENTAL RECEIPTS WHICH SHOWED SHE HAD LIVED MORE THAN THE RECUIRED YEAR AND THE INSPECTOR SHOWED SHE HAD LIVED MORE THAN THE REQUIRED YEAR AND THE INSPECTOR VERIFIED IT WITH THE 'COMITE' PRESIDENT. HE THEN, HOWEVER, TOLD HER TO GO TO THE 'REFORMA URBANA' CFFICE IN GUANABOCOA IN ABOUT FOUR DAYS AND BRING WITH HER A LETTER FROM HER HUSBAND'S PLACE OF EMPLOYMENT STATING WHERE HE WAS AND THE CIRCUMSTANCES OF HIS EXILE. THIS, HE SAID, WAS ESSENTIAL IN ORDER FOR HER TO KEEP THE APARTMENT.

B. SUBJECT WENT TO COMPLY WITH THE REQUEST OF THE ''REFORMA URBANA'' INSPECTOR. SHE KNEW THAT HER HUSBAND HAD WORKED FOR THE ''MINISTERIO DE COMERCIO EXTERIGR'' SO SHE WENT TO THE MINCOMEX OFFICES IN WHAT USED TO BE THE BACARDI BUILDING ON CALLE MONSERRATE IN HAVANA WHERE SHE EXPLAINED HER CASE TO THE INFORMATION CLERK AT THE DOCR. SHE WAS TOLD THAT HER HUSBAND NEVER WORKED THERE.

SHE WAS THEN SENT TO ANOTHER MINCOMEX BUILDING ON CALLE 23 AND

INFANTA IN VEDADO, HAVANA WHERE SHE AGAIN EXPLAINED HER CASE TO THE

RECEPTIONIST AND WAS SENT TO THE 'DIPLOMATIC DEPARTMENT.' THERE

RECEPTIONIST AND WAS SENT TO THE 'DIPLOMATIC DEPARTMENT.' SHE SPOKE TO A GIRL IN THE OFFICE WHO TOLD HER THAT HER HUSBAND WAS UNKNOWN TO THEM. ALTHOUGH MORTIFIED BY THIS RUN-A-ROUND, SUBJECT WENT BACK TO THE BACARDI BUILDING WHERE SHE KNEW HER HUSBAND HAD WORKED AND INSISTED ON SEEING THE CHIEF OF PERSONNEL. SHE WAS ALLOWED TO TALK TO THIS MAN WHOSE NAME SHE COULD NOT RECALL AND ALLOWED FOR HIS HELP IN CHIAINING THE LETTER. HE FINALLY BROUGHT CHE HELD THE SALD WAS USED BUILD AND SALD THAT HE SALD WAS USED BUILD AND SA CUT WHAT HE SAID WAS HER HUSBAND'S FILE AND SAID THAT HE HAD BEEN TRANSFERRED TO ANOTHER MINISTRY BUT CFFERED NO DETAILS. SHE CONTINUED TO APPEAL TO HIM REPEATING THAT HER HUSBAND HAD DESERTED HER AND LEFT HERCIN A DESPERATE SITUATION. THE MAN BROKE DOWN AND TELEPHONED SEGUNDO PEREZ, CHIEF OF PERSONNEL OF MINREX EXPLAINING THAT SUBJECT WAS THE WIFE OF AMMUG-1: AND NEEDED A LETTER FOR THE 'REFORMA URBANA.' THE PERSONNEL CHIEF SENT HER TO THE "MINISTERIO DE RELACIONES. EXTERIORES! , SHE SAYS IT WAS IN BACK OF THE LINEA MATERNITY HOSPITAL, SHERE SHE TRIED TO EXPLAIN HER CASE TO PEREZ BUT WOUND UP TELLING HER STORY TO HIS SECRETARY, A GIRL KNOWN ONLY AS ELSIE /LNU/.
ELSIE KEPT TELLING HER TO COME BACK THE NEXT DAY. SUBJECT KEPT

DISPATCH SHAPPING AND MURRER

RETURNING ALMOST DAILY FOR ABOUT 4 MONTH, DURING WHICH TIME SHE NEVER SAW PEREZ. ONE DAY, HOWEVER, WHILE MAITING OUTSIDE PEREZ. OFFICE, SHE SAW A MAN TALKING WITH ELSIE. SUBJECT WAS SO TIRED OF BEING GIVEN THE RUN-A-ROUND THAT SHE APPROACHED PEREZ AND PLEADED FOR THE LETTER. PEREZ ANSWERED BY SAYING THAT, "IN BACK OF YOUR HUSBAND, THERE ARE GREAT AND GRAVE PROBLEMS." SHE TOLD HIM SHE KNEW NOTHING OF HER HUSBAND'S ACTIVITIES BUT LEEDED THE LETTER OR FACED EVICTION. PEREZ PROMISED TO HAVE THE LETTER READY BY THE NEXT DAY. WHEN SHE RETURNED THE NEXT DAY SHE WAITED ABOUT THREE HOURS FOR AN CLERK TO TYPE THE LETTER WHICH SHE TOOK INSIDE PEREZ! OFFICE FOR AN HIS SIGNATURE. THE LETTER, AS SUBJECT REMEMBERED IT, STATED—TO—THE REFORMA URBANA—MR. SO-AND-SO WENT ON A GOC DELEGATION TO CANADA AND EXILED HIMSELF. HE IS A TRAITOR TO HIS COUNTRY. MRS. /SUBJECT/ HAS REQUESTED THIS LETTER FOR YOUR RECORDS.

SIGNED /SEGUNDO PEREZ/

C. AS A SIDELINE TO SUBJECT'S VISIT TO THE MINREX OFFICES, SHE STATED THAT AFTER ABOUT SEVEN OR EIGHT VISITS SHE BECAME FRIENDLY IN HER CONVERSATION WITH ELSIE AND CONTINUED TO PUSH THE ''POOR LITTLE ME'' APPROACH, ABANDONED AND HELPLESS. ELSIE EVENTUALLY ASKED HER IF SHE WAS EMPLOYED. WHEN SUBJECT REPLIED THAT SHE LIVED ON WHAT HER PARENTS GAVE HER, ELSIE TOLD HER THAT IF SHE WANTED TO, SHE COULD WORK IN A GOVERNMENT POST. SUBJECT STATED THAT SHE HAD CHRONIC BRONCHIAL ASTHMA WHICH PREVENTED HER FROM HOLDING A STEADY JOB. ELSIE THEN TOLD HER, ''ALL RIGHT, IF YOU EVER DECIDE TO WORK, COME AND SEE ME AND I'LL HELP YOU.'' ELSIE NEVER MENTIONED THE TYPE OF WORK SUBJECT YOULD DO AND THE MATTER WAS NEVER BROUGHT UP AGAIN BY EITHER PARTY.

EVERY TEN TO TWENTY DAYS. ABOUT SEVEN LETTERS ARRIVED /STILL CRUDELY OPENED AND RESEALED/ BEFCRE SHE TOLD HER HUSBAND TO WRITE TO HER GAUGHTER FRANCISCA HERNANDEZ AT HER PARENTS! HOME AND TO SIGN THEM ARMANDO RODRIGUEZ WHO LIVED IN MIAMI AND IS MARRIED TO SUBJECT'S COUSIN ALBANIA XMASSIP Y TIMONEDA. AFTER THIS ARRANGEMENT WAS COMPLETED, THEIR LETTERS DID NOT APPEAR TO BE OPENED OR TAMPERED WITH. SEVERAL LETTERS, HOWEVER, FROM HER AUNT AND BROTHER IN MIAMI TO HER MOTHER IN CUBA WERE TAMPERED WITH.

VI. CIRCA JULY 1964 - SUBJECT CONTINUED HER FRIENDLY RELATIONS WITH MARIA MENDIVER, THE ''COMITE'' PRESIDENT AND MENTIONED THAT SHE PLANNED TO GIVE UP HER APARTMENT AND RETURN TO LIVE WITH HER PARENTS. SUBJECT CASUALLY OFFERED MARIA ANYTHING SHE MIGHT NEED IN THE APARTMENT AS SUBJECT KNEW THAT MARIA HAD CONFIDED TO HER NEIGHBORS THAT SHE DESIRED TO HAVE SUBJECT'S SEWING MACHINE.

VII. CIRCA AUGUST 1964 - A. ABCUT THIS TIME SUBJECT BEGAN TO PREPARE FOR HER EXIT FROM CUBA WITH HER CHILDREN. AWARE OF THE MANY DIFFICULTIES SHE WOULD ENCOUNTER IN OBTAINING HER EXIT PERMIT, SHE SOUGHT COUNSEL IN DIFFERENT CHARTERS. HER BROTHER'S GIRL FRIEND GISELA CONFINI SUGGESTED THAT SHE SEE A RELATIVE OF HER'S NAMED ROBERTO /LNU/ WHO WAS A POLICEMAN IN CHARGE OF THE DEPARTMENT THAT HANDLED APPLICATIONS TO LEAVE CUBA AT THE GUANABACOA HAVANA POLICE STATION. THEY MET CONFIDENTIALLY AT GISELA'S GRANDMOTHER'S HOME IN GUANABACOA HAVANA /SUBJECT CANNOT REMEMBER THE ADDRESS/WHERE SHE EXPLAINED /WITHOUT MENTIONING HIS NAME/ HER HUSBAND'S PROBLEM AND HER DESIRE TO LEAVE CLS4. ROBERTO THEN ASKED FOR HER HUSBAND'S NAME WHICH SHE GAVE HIM. ROBERTO SAID HER HUSBAND'S NAME WAS ON EVERY POLICE 'WANTED LIST' AND PREDICTED THAT SHE WOULD HAVE A DIFFICULT TIME LEAVING CUBA. SHE COUNTERED BY SAYING THAT WAS PRECISELY WHY SHE MEEDED HIS HELP. ROBERTO ADVISED HER TO DISCREDIT HER HUSBAND AT EVERY CCCASION EXPLAINING THAT THE MOST IMPORTANT PART IN OBTAINING HER EXIT PERMIT DEPENDED ON THE REPORT SUBMITTED BY THE LOCAL 'COMITE'S'. ROBERTO TOLD HER THAT IF HE WAS STILL IN CHARGE WHEN SHE PRESENTED HER APPLICATION TO LEAVE THE COUNTRY, SHE SHOULD NOT DISPLAY ANY INDICATION SHE KNEW HIM. HE ALSO SAID HE WOULD LOOK INTO HER CASE AND REVIEW THE REPORTS THE DIFFERENT 'COMITES' MADE ON HER STER WHICH HE WOULD BE ABLE TO ADVISE HER TET THE REPORTS WERE AND REVIEW THE REPORTS THE

OF HER APPLICATION. AS THINGS TURNED OUT, THIS SYSTEM OF APPLYING TO THE GOO THROUGH THE POLICE STATION TO LEAVE THE COUNTRY WAS CHANGED A FEW MONTHS LATER, AND SUBJECT HAD NO REASON TO USE ROBERTO'S AID ALTHOUGH SHE HEEDED HIS ADVICE.

B. ANOTHER FACTOR WORKING AGAINST SUBJECT AT THIS TIME WAS THE 'HUSBAND AND WIFE' TEAM OF ANTONIO AMORALES GOMEZ, AKA C'NICO' AND ANGELA XDE ARMAS, AKA C'CIQUTA.' WHEN SUBJECT AND HER HUSBAND MOVED INTO THE APARTMENT HOUSE IN SEPTEMBER 1963, SOME OF THEIR NEIGHBORS WERE THE ABOVE MENTIONED COUPLE. SUBJECT'S HUSBAND ORDERED HER NOT TO ENTER INTO FRIENDLY RELATIONS WITH THE COUPLE SINCE ANTONIO HAD BEEN A SUBORDINATE OF HIS IN THE POLICE DEPARTMENT. AS A RESULT THEIRS WAS A 'HELLO AND GOODBYE' RELATIONSHIP UNTIL SHORTLY AFTER WORD OF HER HUSBAND'S DEFECTION BECAME KNOWN CIRCA JUNE/JULY 1964. THEN ONE DAY SUBJECT'S BOG APPEARED TO HAVE BEEN POISONED. ALTHOUGH SUBJECT HAD NO PROOF, SHE SUSPECTED THAT ANGELA POISONED THE DOG TO OBTAIN AN ENTREE TO HER. ANGELA BEGAN TO VISIT SUBJECT'S APARTMENT AND ASKED QUESTIONS ABOUT HER HUSBAND. SUBJECT, WHO SUSPECTED ANGELA'S MOTIVES FOR BEING SO FRIENDLY, MAINTAINED THE STORY THAT HER HUSBAND WAS A DIRTY SO-AND-SO WHO HAD LEFT HER. SUBJECT DID NOT VISIT ANGELA'S APARTMENT AND HAD NO DIRECT CONTACT WITH ANTONIO EXCEPT FOR A CASUAL GREETING IN THE HALL.

VIII. CIRCA MID AUGUST 1964 - DETERMINED TO SEEK A LEGAL WAY OUT OF CUBA, SUBJECT COMMENCED -

A DETERMINED CAMPAIGN TO WIN OVER THE "COMITES". AS ROBERTO HAD SUGGESTED. HER FIRST CANDIDATE WAS MARIA MENDIVER. SUBJECT BEGAN TO PLANT IN MARIA'S MIND THE IDEA THAT SUBJECT'S AUNT IN MIAMI /CARIDAD ROSARIO XTIMONEDA Y VALDES/ A U.S. RESIDENT FOR TEN YEARS WAS ANXIOUS TO HAVE SUBJECT VISIT HER. SUBJECT INTIMATED THAT SHE WAS STILL YOUNG ENOUGH TO ''ENJOY LIFE,'' AND THAT BEING SO CLOSE TO HER PARENTS RESTRICTED HER FREEDOM OF ACTION. SHE ALSO POINTED OUT SHE WANTED TO TAKE HER SON AWAY FROM THE COMPULSORY MILITARY TRAINING. MARIA APPEARED TO BE UNDERSTANDING AND SAID, ''EACH PERSON IS THE MASTER OF HIS DESTINY AND IF YOU WANT TO GO, YOU SHOULD.'' TO MAKE IT APPEAR THAT THIS WAS NOT A HASTILY PREPARED TRIP TO JOIN HER HUSBAND, SUBJECT SHOWED PICTURES OF HER AUNT IN MIAMI - A BIRTHDAY CARD DATED 1956 INVITING SUBJECT FOR A VISIT - AND PASSPORTS ISSUED IN 1962. AT THAT TIME SHE HAD THOUGHT OF COMING TO THE U.S. BUT THE OCTOBER 1962 CRISIS CUT OFF AIR FLIGHTS TO MIAMI. SUBJECT TOLD MARIA THAT HER AUNT WAS SENDING HER THE AIRFARE TO SPAIN AND SHE WAS OBTAINING THE VISAS. IN REALITY, HER HUSBAND WAS INDICATING THIS PLAN IN HIS LETTERS TO HER. IN ADDITION TO PLANTING THIS "SEED" IN MARIA'S MIND, SUBJECT REALITY, AGAIN PLACED EVERYTHING IN HER APARTMENT AT MARIA'S DISPOSAL, ALTHOUGH MARIA TRIED TO APPEAR INDIFFERENT TO THIS OFFER, SUBJECT KNEW SHE HAD STRUCK THE RIGHT CHORD. MARIA THEN CONFIDED TO SUBJECT THAT THE ''G-2'' HAD BEEN BACK ABOUT THREE TIMES TO CHECK ON HER MOVEMENTS AND WANTED TO KNO! WHAT INCOME SUBJECT HAD AND IF SHE HAD ANY CONTACT WITH STRANGE PERSONS. MARIA SAID SHE TOLD THEM THAT HER PARENTS SUPPORTED HER AND THAT SHE HAD NOT SEEN SUBJECT CON-TACTING ANY STRANGE OR UNKNOWN PERSONS.

B. SUBJECT STATED THAT DURING THE FIRST FIVE MONTHS AFTER HER HUSBAND DEFECTED SHE NOTICED STRANGE MEN WHO APPEARED TO BE WATCHING HER MOVEMENTS WHEN SHE WENT HOME AT NIGHT FROM HER PARENT'S HOME. SHE BELIEVED THAT ON ABOUT SIX OCCASIONS THREE DIFFERENT MEN LURKED IN THE UNLIT STREET OF HER APARTMENT CHECKING ON HER ACTIVITIES. SHE STATED THAT IN ORDER NOT TO ATTRACT THEIR ATTENTION, SHE NEVER LOOKED AT THEM AND THE DARK STREETS PREVENTED HER FROM DISTINGUISHING THEIR FEATURES BUT SHE FELT CERTAIN THEY WERE FOLLOWING HER. THESE MEN NEVER MADE ANY ATTEMPT TO CONTACT HER. SUBJECT STATED SHE LAST SAW ONE OF THESE NIGHT OBSERVERS ABOUT JANUARY 1965.

C. AT HER PARENTS! HOME SUBJECT NOTICED ANOTHER
TYPE OF SURVEILLANCE WHICH WAS CONDUCTED DURING THE DAY. FROM TIME
TO TIME A SMALL BALCK CAR WOULD PULL UP IN FRONT OF THE HOUSE AND A TALL STRONG LUCKING NEGRO "OULD GET OUT AND STAND VATCH FOR AN HOUR OR TWO AFTER WHICH THE SMALL BLACK CAR WOULD PICK HIM UP. PROGEDURE WAS REPEATED ABOUT FOUR OR FIVE TIMES AND LAST OCCURRED ABOUT SEPTEMBER OR OCTOBER 1964. SHE PRESUMED THIS MAN WAS WATCHING HER SINCE HE WAS UNKNOWN IN THE REIGHBORHOOD AND STATIONED HIMSELF IN FRONT OF THE HOUSE WITHOUT ANY APPARENT REASON. SUBJECT SAID SHE NEVER SAW THIS MAN CLOSE UP. A RELATIVE OF ONE OF HER GIRL FRIENDS WAS A SPANIARD NAMED JOSE /LNU/ AND HE OBTAINED THE LETTERS FOR SUBJECT. WHEN SUBJECT PRESENTED THE LETTERS AT THE CONSULATE SHE WAS GIVEN A QUESTIONNAIRE /GENERAL BIOGRAPHIC DATA/ TO COMPLETE AND WAS TOLD TO RETURN THE NEXT DAY WITH THE COM-PLETED QUESTIONNAIRE AND FOUR PHOTOGRAPHS OF EACH APPLICANT. NEXT DAY SHE WAS INSTRUCTED TO RETURN IN FIFTEEN DAYS TO PICK UP THEIR THERS AND THE TWO CHILDREN'S VISAS. SHE RECEIVED THEM ABOUT MID NOVEMBER 1964.
- CIRCA MID NOVEMBER 1964 SUBJECT RECEIVED MONEY ORDERS IN THE AMOUNT OF \$1252.00 FOR THEIR PASSAGE TO SPAIN AND TOOK THEM TO THE BANCO NACIONAL DE CUBA WHERE THEY TOLD HER IT WOULD TAKE ABOUT FORTY-FIVE DAYS TO PROCESS HER CASE. AT THE END OF THIS PERIOD SHE WAS GIVEN A DOCUMENT WHICH IN EFFECT STATED SHE HAD \$1252.00 IN FOREIGN EXCHANGE DEPOSITED WITH THE BANK FOR THE PURCHASE OF AIR-LINE TICKETS.
- XI. CIRCA OCTOBER-NOVEMBER 1964 A. SUBJECT COMPLAINED FREQUENTLY TO ALL HER NEIGHBORS ABOUT THE PROBLEMS IN OBTAINING THE EXIT PERMITS AND HOW WORKIED SHE WAS BECAUSE HER HUSBAND'S NAME APPEARED ON THE APARTMENT RENTAL COUTRACT. ANGELA MADE A REVEALING COMMENT, "DON'T WORRY, THERE ARE INVESTIGATIONS AND MORE WILL FOLLOW BE-CAUSE, AFTER ALL, THIS WAS HIS HOUSE, BUT DON'T WORRY. THEY CAN'T BLAME YOU BECAUSE HE WAS BAD. "
- B. TRYING TO DRAW HER OUT, SUBJECT SAID, "THAT'S WHAT YOU SAY, BUT LET'S WAIT TO SEE WHAT THEY THINK."
- C. IT WAS HERE THAT ANGELA ADMITTED THAT SHE WAS DOING INVESTIGATIVE YORK FOR HER HUSBAND YHO WAS MORKING FOR THE DTI AND PURS, EXPLAINING SHE HAD INVESTIGATED A MAN THE PREVIOUS DAY YHO WANTED TO CHANGE HIS JOB. SHE DID NOT IDENTIFY THE MAN BUT SAID THE INVESTIGATION SHOWED HE HAD SPOKEN AGAINST THE REGIME. AS A RESULT, ANGELA SAID HE HAD RECOMMENDED AGAINST THE TRANSFER IN JOBS. ANGELA CONTINUED, PREVENTINE KNOWS YOU ARE NOT WITH THE GOVERNMENT BUT THAT YOU RESPECT EVERYONE. YOU HAVE REVER DONE ANYTHING WRONG. YOU CAN TRUST ME. BECAUSE I AM AMONG THEM, I KNOW. I CAN ASSURE YOU THAT YOU WILL NOT HAVE ANY TROUBLE, BUT, PLEASE DO NOT DISCUSS THIS WITH ANYONE. I'M TELLING YOU THIS BECAUSE YOU ARE A GOOD GIRL AND I FEEL SORRY FOR YOU. SINCE MY HUSBAND IS IN THE DTI AND A MEMBER OF THE PARTY, WHAT I'M TELLING

ANGELA WOUND UP BY SHOWING SUBJECT FOUR DIFFERENT CARNETS SHE HAD IN HER POSSESSION - 1/ BLOOD DONOR, 2/ FEDERACION DE MUJERES CUBANA /FMC/, 3/ MILITIA /LOCALE UNKHOWI/ AND 4/ CERTIFICATE FOR VOLUNTEER WORK.

XII. CIRCA ELD OF DECEMBER 1964 - WHEN THE BANCO NACIONAL AUTHORIZED HER FOREIGN EXCHANGE CREDITS FOR THE AIRLINE FARES, SUBJECT PLANNED TO PRESENT HER DOCUMENTATION FOR EXIT THROUGH SPAIN. HER HUSBAND HOWEVER WROTE STATING THAT HE EXPECTED TO OBTAIN MEXICAN VISAS SHORTLY AND ASKED HER TO CONSIDER THIS POSSIBILITY. SUBJECT THEN DECIDED TO WAIT FOR THE MEXICAN VISAS.

XIII. CIRCA 8 OR 10 FEBRUARY 1965 - AFTER SEVERAL VISITS TO THE MEXICAN CONSULATE ON CALLE 12 BETWEEN 5TH AND 6TH AVENUE, SUBJECT SAW HER NAME / AND THOSE OF THE CHILDREN/ ON A LIST POSTED OUTSIDE OF THE CONSULATE WHICH LISTED THE VISAS APPROVED BY THE GOM. XIV. 15 FEBRUARY 1965 - SUBJECT SENT A TELEGRAM /AT THE COJIMAR HAVANA POST OFFICE/ TO - ''JEFE DE IMMIGRACION'' /CHIEF OF IMMIGRATION/ 'MINISTERIO DEL INTERIOR'' /MINISTRY OF INTERIOR/ HAVANA. /TEST/ '' REQUEST PRESENTATION OF DOCUMENTS VIA MEXICO. NUMBER OF PASSPORT AND VISA. /SIGNED/ NAME_AND_ADDRESS OF SUBJECT. SUBJECT SENT AN IDENTICAL TELEGRAM IN THE NAMES OF HER CHILDREN WHO HAVE ALWAYS LIVED WITH THEIR GRANDPARENTS.

XV. 20 FEBRUARY 1965 - A. ABOUT 1300 HOURS THAT AFTERNOON TWO MEN IN REBEL ARMY UNIFORM WITH NO INSIGNIA CAME TO HER APARTMENT. THEY WERE ACCOMPANIED BY MARIA GOMEZ, HEAD OF THE DISTRICT NEIGHBOR-HOOD VIGILANTE COMMITTEE. THEY DID NOT IDENTIFY THEMSELVES AND INQUIRED AS TO WHETHER SUBJECT HAD AN EXIT PERMIT AS WELL AS OTHER PERTINENT DOCUMENTATION. THE TWO DSE AGENTS ALSO INQUIRED AS TO WHETHER OR NOT SHE PLANNED TO JOIN HER HUSBAND AND WHERE HE WAS LOCATED. SHE NOTICED THAT THE DSE AGENT WHO SIGNED RECORDED HIS NAME AS 'RAMOS.'' HE ALSO STAMPED A SMALL 'QUARTER' SIZE INK SEAL IN THE BACK PAGES OF THEIR PASSPORT WHICH CONTAINED THE INSCRIPTION

PRESENT YOURSELF 72 HOURS BEFORE DEPARTURE AT OFFICE OF CUBANA DE AVIACION ON PRADO OR LOSE THE RIGHT TO DEPART.'' /FOR EACH FAMILY GROUP/. THE LIST FOR THE MALE INCLUDED - THREE SUITS /INCLUDING THE ONE WORN ON THE TRIP, THREE SHIRTS AND TIES, THREE UNDERSHIRTS, ONE OVERCOAT, TWO HANDKERCHIEFS, TWO PAIRS OF CUBAN USED SHOES. MONEY WAS NOT ALLOWED TO BE TAKEN CUT OF THE COUNTRY.

XIX. CIRCA 12 APRIL 1965 - SUBJECT LEARNED CONFIDENTIALLY FROM MARIA MENDIVER, THAT THE ''G-2'' WAS CONDUCTING ANOTHER INVESTIGATION OF HER ACTIVITIES. MARIA SAID THAT AN INFORMER IN A NEARBY ''COMITE'' HAD DENOUNCED SUBJECT AS MEETING WITH COUNTERREVOLUTIONARIES IN HER HCME AND OF REGEIVING LETTERS FROM HER HUSBAND. ALTHOUGH SUBJECT DID NOT KNOW THE DETAILS AND THE PERSONALITIES INVOLVED IN THE DENUNCIATION, SHE BELIEVED THAT IT STEMMED FROM GRACIELA /LNU/ AND EVA RODRIGUEZ WHC DISCUSSED HER CASE INNOCENTLY WITH OTHER PERSONS. MARIA ASSURED SUBJECT THAT SHE HAD ONCE AGAIN BACKED HER UP AND HAD RENDERED A FAVORABLE REPORT. IN SPITE OF THESE ASSURING WORDS, SUBJECT WAS NOT CERTAIN OF THE OUTCOME UNTIL SHE LANDED IN MEXICO ON 14 APRIL 1965.

XX. 14 APRIL 1965 - A. SUBJECT STATED THAT SHE HAD TAKEN THE PRESCRIBED BAGGAGE TO THE AIRPORT ON THE PREVIOUS DAY SO THAT GOC AUTHORITIES COULD CHECK IT BEFORE DEPARTURE.

- B. THEY ARRIVED AT THE AIRPORT ABOUT 0430 HOURS ALTHOUGH THE SCHEDULED DEPARTURE TIME WAS 0530 HOURS. ONCE THERE, THEY WERE INFORMED THAT THE PLANE WOULD BE DELAYED IN DEPARTING AND THEY WERE NOT ALLOWED TO LEAVE THE AIRPORT. DURING THE WAITING PERIOD /THE PLANE DID NOT TAKE OFF UNTIL ABOUT 1730 HOURS, SUBJECT DID NOT SEE HER DSE INTERROGATORS AND WAS NOT QUESTIONED BY ANYONE REGARDING HER HUSBAND.
- 4. JMWAVE TRACES ON INDIVIDUALS MENTIONED IN SUBJECT'S DEBRIEFING REVEAL THE FOLLOWING -
- A. ONE MARIA GOMEZ WAS REPORTED IN APRIL 1959 AS A CUBAN DELEGATE TO THE CONGRESS FOR DISARMAMENT AND INTERNATIONAL COOPERATION WHICH TOOK PLACE IN STOCKHOLM 16-22 JULY 1958 (FJTA-) 22 25699, 7 APRIL 1959/.
- B. ONE ANTONIO MORALES GOMEZ /PRIVATE/ WAS INCLUDED IN DECEMBER 1960 ON A LIST OF CUBAN G-2 AND DIER PERSONNEL, ORDER NO.164 OF THE CUBAN REBEL ARMY, HKHA-7290, 28 DECEMBER 1960/. MORALES ALSO WAS REPORTED IN MARCH 1961 AS A MEMBER OF THE FOURTH MILITARY DISTRICT IN MATANZAS PROVINCE, G-2 /CSCI 3/764,490 OF 20 MARCH 1961/.
- C. SEGUNDO PEREZ IS IDENTICAL WITH THE SUBJECT OF 201-342580, A CUBAN INTELLIGENCE OFFICER AND CHIEF OF PERSONNEL IN MINREX WHO HAS SERVED ON OCCASION AS A BODYGUARD FOR CUBAN OFFICERS TRAVELLING ABROAD.
