<p>1. The purpose of this dispatch is to request information on a radio beacon system that may be used as an aid to a mobile physical surveillance team.</p> <p>2. Specifically, it is believed that a radio transmitter that could be easily attached to the underside of a target automobile and whose signal would act as a beacon for other suitably equipped cars would be very useful here. It would enable the surveillance team to lose visual contact with the target and still maintain the surveillance.</p> <p>3. In considering this type of operational aid two very desirable features become apparent. They are:</p> <ul style="list-style-type: none"> a. That the beacon be easily attachable so that elaborate installation procedures are not required. b. That the receiving equipment easily operable and concealable or readily removable from the vehicle. <p>Obviously other features such as long range and battery pack life are also desirable but the Station would prefer not to establish</p> <p style="text-align: right;">(continued)</p>
