MEMORANDUM No. 1

BUBJECT: Garrison and the Kennedy Assassination

I. SUHMARY

This memorandum provides information about twenty persons who have not been listed previously in this series, who are involved in the Carrison case, and who have or have claimed to have a connection with the Central Intelligence Agency. One, William Clarens WOOD, is a former staff employes.

II. PERSONNEL

- 1. Tholias Edward BECKHAM (aka Mars EVANS)
- a. GALRISON suppossed BECKHAM 30 December 1767 and an Omaha, Rebraska, judge ordered him to return to Louisiana 31 January 1763. BECKHAM says he nolved for glo ARCACHA Smith raise funds for Guban revolutionary forces in New Orleans in 1762. BECKHAM is an entertainer-evangelist who uses the stage name of Mark EVANS.
- b. On 3 January 1/63 BECKHAM allegedly told David LEWIS of New Orleans that he, BLCKHAM, and a Jin LNU 'from Onaha' are agents of the CIA.
 - c. RID has no record of BECKHAM.
- 2. Melvin Balli
 - a. BELLI was a delense attorney for Jack HUBY.
- b. Jim GARRISON was a weekend quest of BELLI when GARRISON visited San Francisco in October 1967.



c. BELLI was re-priedly involved in illicit drug traific with Worris LLOWITZ in 1958. ELOWITZ was a suspected contact of Lucky LUCIANO.

3. Donald Dean BOHNING (201-61370))

- a. BCHNING is the Latin American Editor of the Miami Herald. He was granted a PCSA on 21 August 1967 and a CSA on 14 November 1967. He is AMCARBON-3.
- b. BOHNING re-orted he was contacted on 28 March 1968 by a Winston SHITH who claimed to be investigating Rolando MASFERRER for Jing GARRISON.

4. Columel L. Robert CASTORR

- a. Col. CASTORR allegedly that with Jack RUBY, Robert CERRIN, and others in Dallas in 1362 to lian a Cuban smuggling operation. CASTORR is also allegedly an associate of General Edwin A. FALKER. Joachim JOESTEN and others have broadly binted that CASTORR is associated with CIA.
- b. There is no record of agency association with CASTORR. As SBI report of 13 March 1963 re, orted that CASTORR had lunch with Vixtor Ivanovich MIRONOV (201-731045), a KOB officer at the Soviet Elabassy in Washington.

5. Lloyd J. COBB

- a. As President of the New Orleans Trade Center, COBB was, according to Not or Politics, the Poss' of Clay SHAW.
- b. COBB was granted a CSC on 3 October 1753 for use on a private attorneys' panel for the CGC. COBB was granted a SSA on 17 June 1767 to permit contact and assess, tent in connection with his use on a cleared attorneys' anel for the OGC.

6. Michael Charles CONLEY

- a. Michael Charles CONCI Y is an avarent US Government source of Ropert Kennett BROWN.
- b. A Dr. Michael C. CONLLY an lied for Agency employment in 1954. Identity with a, above, has not seen established.

7. Allen W. DULLES

- a. GARRISON subjected Ar. DULLES on... 16 February 1)66 as a material witness.
- b. On 7 March 1966 Judge Matthew BRANIFF Issued a second subposes for Mr. DULLES.
- c. On 22 May 1963 GARRISON's office accused the Justice Department of refusing to cooperate in the supportaing of Mr. DULLES as a witness.

8. Wieslaw GORNICKI (201-198323)

- a. GORNICKI is a Polish journalist who was the author of a long article on the GARRISON investigation in Prolityka" No. 1 (366), Year XII Warsaw, 6 January 1968.
- b. GORNICKI was the subject of an unsuccessful recruitment attends in 1965 while he was a correspondent at the UN.

9. Marshall bileon HOUTS (201-333160)

- a. HOUTs, a for her FEI agent, is the author of an article in Medical Economics 4 March 1906 which criticized the autopsy of President Connedy.
- b. HOUTS served with OSS in Burna during World War II and was involved in the missparo ristion of government property. HOUTS unsuccessfully applied for Agency employment in 1952.
- 10. Guy Persac JOHNSON (201-207873)
- a. JOHNSON was an early detense counsel for Clay SHAW.
- b. A POA was requested in May 195; for JOHNSON to be used on Guain as a contract agent for OLKODIAK (training base on Sairan). The request for the POA was later cancelled.

11. Villiam R. KLEIN

a. According to Plot or Politics KLEIN was an

incorporator of Friends of Democratic Cuba, along with
Guy BANDTER, William DALZELL, and Grady C. DURHAM.
KLEIN denied contact with DURHAM, BANISTER, and Friends
of Democratic Cuba. He admitted association with DALZELL to
set up the Free Voice of Latin America. KELIN seems to be
a personal friend of Jim GARRISON.

5. KLEIN applied for agency employment in 1965 but accepted a job with the US Navy General Counsel's Office.

12. Robert Evensen LEE

- a. LEE was an Assistant District Attorney for Jim GARRISON from 1 January 1967 to 1 January 1963.
 - 5. LEE applied for agency employment on 5 January 1968.
- 13. William Richard MARTIN (201-243516)
- a. MARTIN was an Assistant Listrict Attorney for Jim GARRISON until December 1967.
- 5. MARTIN was a DCS contact and source in 1964 and 1965 when he was Director of International selations and World Trade of International flouse in New Orleans.

14. Estman MORIN (201-10/129)

- a. MORIN is the author of Assassination, a pro-warren Commission book.
- b. MORIN provided information to OSS on his interament in Indo China during the early part of Forld Far II.
- c. MORIN was considered for the job of President of the Committee for a Free Asia in 1951 and the job of President of DTFILLAK (Asia Foundation) in 1953.

15. Lr. Alton OCHSNER (231-634497)

a. An FBI confidential informant reported on 2: April 1983 that Jim GARRISON believes Dr. OCHSNER was a principal involved in the conspiracy to assassinate President Kennedy.

- b. Fr. OCHENER is Director of the Ochener Foundation, head of the Ochener Clinic, and President of the Information Council of America. He is a world-famous surgeon.
- c. Dr. OCHSNER was of contact interest in October 1747 and November 1943. He has been a cleared source since 13 May 1755. The last official contact with Dr. OCHSNER personally occurred on a January 1762 and with the Ochsner Clinic on 3 November 1963.

16. Robert PERRIN

- a. Robert PERRIN allegedly met with Jack RUBY, Col. L. Robert CASTORR, and others in Dallas in 1962 to plan a Colan shoughing operation. **ERRIN has been accused of being a CIA gen-runner in Spain and in Cuba.
- b. A Lt. (jg) Robert Polloch PERRIN filed a personal history statement with ONE in January 1944. There is no indication he ever served with ONE or was later connected with the Agency.

17. Benja rin SONNENBERG

- A. Mark LANE said on the acknowledgement page of Rush To Indgerment: I am decily indebted to Benjamin SCHNENHERG, Ir. whose numerous and tavaluable suggestions have found their way into total volume."
- Benjamin SUNNENBERG was granted a CSA on 29 June 1939 for use under Project CXENCHANT. The CSA was revalidated for continued use on 28 July 1965.
- c. An April 1959 Dunn and Bradstreet report listed and an April 1959 Dunn and Bradstreet report listed and NNENBERG as a director of the publishing tirm of Henry Holt and Co. than, Inc., 333 Manison Ave., New York City. Rush To Judge then was published by Holt, Rinehart and bilson Inc., 333 Manison Ave., ostensibly the same company.
- d. An October 1951 FBI report said that in 1933 Alfred d. STERN earmarked \$3000 in a bank account to guarantee a bank loan made to SINNENSERG.

- e. There is no indication that SUNNENBERG ever used the term 'punior' and it is not known yet if he has a son of that name.
- 18. Mr. and Mrs. Edgar Bloom STERN (He is 201-173541)
- a. Jack ROGERS, the committee counsel for the joint legislative Committee on Un-American Activities for the State of Louisiana, reported to the ECS on 1 June 1967, that GARRISON had been receiving contributions and monetary support from Mrs. Edgar B. STERN.
- 5. Mrs. Edgar B. ETERN is the former Edith ROSENWALD and the former sister-in-law of Alfred K. ETERN.
- c. Clay SHAW attended a party given by 'an old friend', Evith ITFRN, apparently in October 1967.
- d. Edgar B. STERN was granted a covert clearance in January 1903 for use as a donor in Project LPCOIN. This clearance was cancelled in be tember 1966.
- e. Pidilo Maurice STERN, son of the above mentioned couple, was granted a liaison clearance in March 1961 when he was the Levily Assistant Secretary of State for Public Affairs. Philip STERN was also named as one of a "board of advisors" to Subert HUMPHREY in 1964.
- 19. Menroe SULLIVAN
- a. SULLIVAN claimed to be with Clay SHAW in ban Francisco all day 22 November 1963.
- 5. SULLIVAN was granted a CSA on 10 December 1952 to termit utilization under Project CKENCHANT.
- 20. Villia :: Clarens 7: 000 (2)1-334272)
- a. A Bill WOOD, using the name Bill BOXLEY, is investigating UL and its operations for H & GARRISON.
- b. Bill WOOD is believed to be identical with William Clarens hOOD, a former staff employee of tids Agency.

c. billian Clarens WCAD, born 17 August 1920, was approved for OSS duty in December 1944, but was not nititized. On 13 December 1950 WCX D was granted a CSC for utilization as a Stalf Agent with Project TPFOCUS. He suffered a nervous breakdown in March 1952. He was assigned to OTR as an instructor (CS-11) in May 1952. He resigned 27 January 1953, after his resignation had been requested, because of alcoholism. While under the influence of sodium pentothel during a medical operation in July 1953 EOOD made statements abowing extreme antagonism toward the Agency. The FBI reported in April 1957 that EOOD had offered assistance to the Nationalist Chinese Intelligence Service. DCS requested clearance to use WOOD in February 1957 but dropped the request after the FBI reported that he was drinking heavily again.
