1. ANCALL-1, WHO HAD ORIGINALLY PLANNED GO MEXI SELL AMNAWK AND AMMAIL ON INTEGRATION OF ADR INTO ANCIGAR, UNABLE TRAVEL MEXI DUE LACK OF MEXI VISA. A-1 WILL ARRIVE MASH FROM SAN JUAN 6 SEPT WHERE HE WILL REGISTER PANAMERICAN HOTEL, NEAR GREYHOUND BUS STATION, UNDER NAME OF JOAQUIN GOMEZ. A-1 WILL RETURN HAVA 9 OR 12 SEPT. DURING MASH VISIT A-1 STATES HE WILL CONTACT ARMANDO FERNANDEZ WHOM HE DESCRIBES AS FRIEND OF AMNAWK.

2. A-1 DOES NOT EXPECT CONTACT IN MASH, BUT TOLD HE MAY BE CONTACTED BY PERSON IDENTIFYING HIMSELF AS "FRIEND OF JAMES." A-1 NOT WITTING KUBARK OR ODYCKE INTEREST, HOWEVER HE KNOWS STATION CUTOUT [JAMES O'MAILIA] AS LOCAL REP OF CHRISTIAN FELLOWSHIP FUND WHO WELL CONNECTED LOCAL ODACID. A-1 CLAIMS HEAD LABOR SECTOR OF ADR, AND DIRECT CONTACT WITH MAHOLO RAY. A-1 FORMER SEC GEN FOR FOREIGN RELATIONS CTC, AND PRESENTLY SEC GEN OF UNION TRABAJADORES CRISTIANOS, WHICH KUBARK SUPPORTED.

4. A-1 REPORTS ADR CHANGING ITS NAME TO MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (MRP) ORDER GIVE ORGANIZATION PERMANENT RATHER THAN TRANSIENT CHARACTER. NAME CHANGED AT INSISTENCE OF RAY.
