SITREP ON AFFILIATES POSITIONS ON AMBUD:

1. DMR WAS URGED STRONGLY BY (BINAURAL) TO OFFER SUPPORT TO AMBUD-1 BY SEEKING REPRESENTATION ON AMBUD. DMR UNWILLING UNTIL THEY RECEIVED WORD FROM THEIR CLANDESTINE LEADERSHIP WITHIN PERUMEN WHICH SHOULD BE FORTHCOMING IN APPROXIMATELY TEN DAYS.
2. ALABAU TRELLES REPORTED 8 NOV TO (BINAURAL) THAT ANCORE-2 CONCILLIATORY MOVE TOWARD AMBUD WAS ANCORE-2'S IDEA WITHOUT APPROVAL OF EITHER GARCERAN OR ALABAU, THAT ANCORE-2 SYMPATHIZES WITH GARCERAN BUT WISHES TO KEEP ONE FOOT IN AMBUD FOR FINANCIAL REASONS.
