1. FULL INFO OBTAINED CARLOS BANDIN AKA LAZARO DURING DEBRIEFING 17 OCT: LAZARO PRESENT LEADER MRR. ESTEBAN HIS DEPUTY, ACTING AS CHIEF IN HIS ABSENCE. AMBRONC-5 WILL BE NATIONAL MILITARY COORDINATOR UPON RETURN PSRUMEN. ANJAVA-4 PLANS RETURN PSRUMEN WITH LAZARO. UPON THEIR ARRIVAL THE EXEC COMMITTEE MRR WILL DECIDE WHAT POSITION EACH WILL FILL. SUBJECTS INFORMED C/O THAT THEY WOULD ABIDE BY WHATEVER DECISION THE EXECUTIVE COMMITTEE MAKES AND THAT THERE WILL BE NO CONFLICT. LAZARO STATED THAT THERE IS NOW COMPLETE COOPERATION PSRUMEN BETWEEN MRR, ~~MSP~~, RESCATE, JO NOV AND THAT IT IS POSSIBLE TO UNITE THESE GROUPS AT THIS TIME. HE BELIEVES THAT THE DRE AND MDC WOULD ALSO JOIN SUCH AN ORGANIZATION. SUBJECT STATED THAT THE ABOVE SIX GROUPS ARE THE ONLY SIGNIFICANT GROUPS IN PSRUMEN. ABOVE GROUPS ARE INTERESTED IN HAVING SUPPLIES SENT TO THEM THROUGH ONE CENTRAL POINT TO AVOID CONFLICTS WITH EACH OTHER. LAZARO INFORMED C/O THAT GROUP LEADERS INSIDE COULD POSSIBLY ELECT AN OVERALL COORDINATOR.

2. LAZARO ARRESTED DUE SABORIT WHO WORKED AMPUG NET. AMPUG INTRODUCED LAZARO TO SABORIT AT TIME MRR USING PEKLOK CHANNEL. (THIS

PROBABLE TOOK PLACE AT TIME <sup>02</sup> (NO)TLOX RADIO BEING TRANSFERRED FROM VENEZUELAN EMBASSY TO A SAFEHOUSE.) LAZARO STATED THAT AMPUG "TALKED TOO MUCH" AND CONFIDED IN SABORIT. LAZARO BELIEVES AMPUG WAS IN THE ROOM NEXT TO HIM AT G-2 HOUSE WHERE HE WAS IN SOLITARY CONFINEMENT FOR 3 WKS. LAZARO BELIEVES RECOGNIZED VOICE IN NEXT ROOM AS THAT OF AMPUG AND STATED SUBJECT RECEIVED PREFERENTIAL TREATMENT; WATER MORE THAN ONCE A DAY, SHOWERS, ETC.

3. FYI, SUBJECT ALSO KNEW AMCOAX-1 BY THE NAME, BY CHACHO AND BY ERNESTO. LAZARO PLANS RETURN PBRUMEN WITHIN ONE MONTH. HE IS KNOWLEDGEABLE ALL ACTIVITIES MRR AND WHILE IN PBRINE WILL ATTEMPT GET FACTIONS MRR WORK TOGETHER. DEBRIEFING REPORT FOLLOWS BY DISPATCH. DEBRIEFING RE <sup>02</sup> (NO)TLOX CIRCUIT WILL FOLLOW.
