 ARRIVED AT ANYTHING CONCRETE YET HOWEVER ATMOSPHERE AT PRESENT VERY FAVORABLE
 FOR COORDINATING UNITY OF STRUGGLE. I AM TRYING TO GET MDC AND DHE TO TAKE PART
 IN THOSE CONVERSATIONS. ESTEBAN
