1. SGT WAS A PASSED **(EXOTH-12)** MEETING 9 APRIL. RECEIVED NO REACTION BUT TRIED BRINGING BRIEF DUE POLITICAL CRISIS RE TRIUNVIRATE CHANGES.
2. EVENING 11 APRIL **(EXOTH-12)** DROPPED IN AT COS HOUSE. COS AGAIN BROUGHT UP CISNEROS MATTER AND TRIED GET **(EXOTH-12)** DISCUSS HIS PLANS FOR ACTION BY CUBANS. **(EXOTH-12)** NOT SPECIFIC BUT IMPLIED HE WOULD NOT WORK WITH CISNEROS. BELIEVE HE DISTRUSTED MANOLO RAY CONNECTIONS WITH FLOREZ MARI. RE AMBIDDY-1 SAID ONLY HE TOO HAD HEARD OF EXTENDED VISSX.
3. **(EXOTH-11)** RATHER ASSERTIVE ON CUBAN MATTER AND CUT OFF FURTHER CONVERSATION ON SUBJECT SAYING HE WOULD DO NOTHING WITH ANY CUBANS UNLESS HE KNEW THEY WERE "GUIDED" BY KUBARK.
4. COS HAD INTENDED DISCUSS ABOVE AT HOS 22 APRIL FOLLOWING CONFERENCE BUT UNEXPECTEDLY REQUIRED RETURN TO STATION 19 APRIL. IF ANY FURTHER INFO OBTAINED, WILL CABLE.
