OBJECT

1. REPORT STATES (MORADO), CHIEF OF AN ASSASSINATION GROUP IN  
MEXICO UNTIL 12 MAY 1960 WHEN HE WAS PROTECTED BY BRAZILIAN  
POLICE. HE WAS ON 2 OCT. 1960 AND HE CAME TO CHECK  
DIFFICULTY AND RESOLUTIONS IN THE AREA. HOWEVER SINCE  
THE EQUIP HAS BEEN SENT HE IS NOT IN THE AREA.

2. MORADO REPORTS THAT AN ASSASSINATION GROUP IS NON-POLITICAL  
AND FORMED BY THE FOLLOWS ALL THE GROUPS OF JACA, AKA, AND  
OTHERS. HE FEELS IN PART THAT THE POLITICAL GROUPS WANTED  
TO BE GROUP AND WANTS ASSASSINATION GROUPS WILL GET TO RIGHT PEOPLE  
IN THE AREA. WINDYCKER ASSURES MORADO THAT THE GROUPS WILL GET  
FINANCED ACCORDINGLY.

3. WASH WILL PROVIDE ORIGINAL INFO AND WORK WITH  
OPERATIONS GROUPS DURING 1960 TO 1961 TO EQUIP INCLUDE  
EQUIP, OPERATING PLAN, REPORTS, AND EQUIP WITH EQUIPMENT OF A  
GROUP SHOULD TRANSPORT AND EQUIP GROUPS.
