1. MEXICO ENGLISH LANGUAGE NEWS ARTICLE BY ROBERT S. ALLEN AND PAUL SCOTT DATED TWO MARCH WASHINGTON STATES "STILL SECRET WOPACT REPORT ON OSWALDS SEPTEMBER ACTIVITIES WHICH WAS SENT TO THE STATE DEPARTMENT INTELLIGENCE DIVISION ON OCTOBER ELEVEN ONE NINE SIX THREE COULD POSSIBLY SHED SOME NEW LIGHT ON THE MEXICAN TRIP AND POSSIBLY OTHER LINKS OF THE ACCUSED ASSASSIN."

2. STATION BELIEVES THIS MEMORANDUM MAY BE BASED ON MEXI 6453 DATED 8 OCTOBER 1963. RECOMMEND THAT THIS MEMORANDUM NOT REPEAT NOT BE DECLASSIFIED FOR NEWSPAPER SOURCES SINCE WOULD BLOW LIENVOY AND GIVE GROUNDS FOR CRITICISM AGAINST WOPACT AND LIRAMA. BELIEVE WOULD ALSO FURTHER CONVINCE LIRAMA OF POOR SECURITY IN STATE DEPARTMENT.

3. PLS ADVISE ACTION TAKEN PROTECT LIENVOY.
