1. ODENVY INITIATED MEET WITH MEXI C/O 11 JUNE, WANTED KNOW IF KUBARK ADVISED STATION RE ODENVY DA. MOSTLY WANTED GET ASSURANCE THAT MEXI WOULD NOT JECARDIZE ODENVY DA IN BAKULIN OP. GIVEN EVERY ASSURANCE.

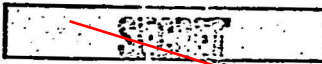
