1. FOLL RECEIVED FROM SMOTH JUNE 61 FROM SOURCE OF UNKNOWN RELIABILITY; PRINCIPALS SUBJECT CASE EXTENDED INVITATION BY CSR INSTITUTE FOR INTERNATIONAL POLITICAL AND ECONOMIC AFFAIRS COME CSR END JUNE 61 OR EARLY SEPT FOR LECTURES SEVERAL CITIES. LECTURE TOPICS NOT INDICATED.

2. ABOVE PASSED ODINCH 16 JUNE 61. LATTER RECEIVED PARALLEL REPORT FROM ODENVY SOURCED BONN ABOUT SAME DATE. ODINCH REQUESTS KUBARK ATTEMPT VERIFY ACTUAL PRESENCE, ACTIVITIES, CONTACTS, ETC. IN CSR OF ZGRACE DEFECTORS, TO INCLUDE ALL OPS DETAILS AVAILABLE. HQS SERIOUSLY DOUBTS SOVS WOULD PERMIT EX-ODINCHERS LEAVE USSR FOR SATELLITE AREAS EVEN FOR HIGH PRIORITY PROPAGANDA PLOY AT THIS TIME, AS LATTER COULD BE ACHIEVED WITH EQUAL SUCCESS VIA SOV CONTROLLED PRESS AND RADIO.
