1. 30 DEC ANPALM-5 ASKED ~~██████████~~ IF HE DID NOT AGREE THAT MOMENT TOO CRITICAL AMPLIFY ANPORT, SUGGESTING BROAD REPRESENTATION COULD BE ACHIEVED LATER IN PROVISIONAL CABINET.

2. ~~██████████~~ REFERRED ANPALM-5 10 MONTHS OF DISCUSSION THIS SUBJECT PLUS 19 DEC MTG WITH BENDER WHEN ENLARGEMENT APPARENTLY AGREED ON. SAID ON CONTRARY THAT MOMENT MORE PROPITIOUS THAN EVER, STARTING WITH ELECTION MANUEL CIBO TO FILL SEAT LEFT VACANT BY ANEER. ANPALM-5 ACCEPTED VIEW JOYLESSLY.

3. COMMENTS: VIEW QUERY AS TRIAL BALLOON BY ANJAG WHO AS WEAKEST MEMBER ANPORT HAS FORMED WITH ANPALM-5 AN INTERNAL BLOC OF TWO, REALIZING THAT EACH ADDITION TO ANPORT WILL DILUTE POWER F ALL.

4. ANPALM-5 OPINED THAT PROVISIONAL PRESIDENT SHOULD COME FROM ANIRON (ANPORT) TO FIX HISTORICAL ROLE OF ANIRON IN ANTI-CASTRO STRUGGLE. ~~██████████~~ SAID MEMBERSHIP NOT ESSENTIAL.

FUSION CHURCH AND STATE BUT AMPALM-5 SUGGESTED WEAKLY THAT
BOZA AS PRIVATE CITIZEN COULD SERVE.
