1. AS YOU KNOW FOMER, OUBAN, AND LOND SERGIO ROJAS NOW IN, PBPINKS AND AS CLOSE FRIEND, STAYING LATTERS HOME, BOTH HAVE BEEN ACTIVE RECENT WEEKS PROMOTE ENTRY ALIANZA AND OR ANUM INSURRENT FACTION INTO AMRASP.
2. UPON REQUEST BENDER MET WITH HIM AND ROJAS 3 OCT. BASIS FOR DISCUSSION WAS THAT TWO MRS EILET MICE FOR ALL INTENTS AND PURPOSES SEPARATE ORGANIZATIONS, THUS DERIVING MEMBERSHIP.
