IF HAVA CONSIDERS THIS REALISTIC AND FIALLO WILLING ACCEPT SUPPORT REQUESTED FOR FAMILY AUTHORIZED.
2. PREFER HOWEVER THAT SUPPORT FIALLO FAMILY COME FROM ~~ANPAINO-5~~ THRU GOOD OFFICES ANPAIN FIVE. SUCH ARRANGEMENT WILL ESTABLISH ELEMENT ~~ANPAINO-5~~ CONTROL OF KEY INDIVIDUAL NACHO RAY GROUP.
3. SUGGEST HAVA MAKE CLEAR ENOUGH ANPAIN FIVE FIALLO INTERIORS AND FINANCIAL NEEDS AND ARRANGE ~~ANPAINO-5~~ COMMITMENT SUPPORT. AFTER WHICH MESSAGE TRANSMITTED ANPAIN FIVE TO FIALLO THIS EFFECT. IN ALL EVENT MUST EXCLUDE ~~ANPAINO-5~~ THIS MATTER IF POSSIBLE.
