The following report was received from Rolando MANGUART Julia, AMOT sub-source in Hayana:

- 1. I wrote you in a previous report about my efforts to unite the different clandestine groups in the western provinces of Cubs. A similar effort will be made in the eastern provinces. I believe that the coming week I shall be able to give you a detailed report about the work that has been done.
- 2. At this moment we are making an inventory of the arms we can count on, and when the time comes, I shall tell you what war materiel we shall need and the places where it can be received. I hope it may be possible to receive aid (from you), as the work which I have been doing is considerable and I have never asked anything of you. I have done everything by myself. But this is a nation-wide thing which requires funds and certain commitments.
- 3. Don't think that the same thing is going to happen that happened to the 60,000 peacs sent to the Unidad Revolucionario and later the 110,000 pesos sent to solve the problem of Humberto SORI Marin. These funds never reached their destination and were managed by Milario, Polin, and Boris. Hilario took asylum in an embassy, and the other two were captured by G-2. I am passing all this information on to you so you will know that I am working here and know everything that does go on. I mention names so that youccan check the information. It is certain that the last two mentioned above have told the G-2 about the codes. They are still detained but they have comforts which other prisoners do not get. There is a statement which they made which says that over there (meaning Miami?) they were told that there were three different persons in Habana - AMRUNG-1, Rafael, and Die 5 R-11 (does he mean himself?) and that the last person was not "a man of confidence", but the first two were the appropriate ones (los indicados). As soon as AMRUNG-1, Rafael and SORI arrived here in Habana I was aware of the fact and could have got in touch with them at any given time. I did not do so because I did not need to see them. On the other hand they did not know me or know where to find me, which is a sign that I was working better and had a better intelligence service than they did. I feel they did not have confidence in me or perhaps thought Icould not be of service to them because of my little experience and youth. They did not give me any help and did not let me use any of the war material that was offered me. I want to demonstrate to you that I am capable of doing the same kind of work, and I want you to recommend me to those gentlemen, whom God keep in glory!

4. Things are well organized here in Cuba and I only count on your aid. I am awaiting any orders you folks may send me. I want to state again that I am doing all this for no reason of personal ambition, and that anything (that you may decide) will be of a provisional character, and once the fight is over (which will be soon) I shall go wherever you send me, like a good soldier. I am just waiting for instructions.
