1. FOR SOME TIME, MANY ANTI-CASTRO ACTIVITIES SPONSORED BY STATION BEEN ATTRIBUTED ERRONEOUSLY BY GOVT AND OTHERS TO MARINAS. LEFTIST GOB AND DEPUTIES BEEN PUTTING PRESSURE, THEREFORE, ON PRES PAZ, TO EXPEL HIM. WHEN OLIVARES VISIT IMMINENT, MINISTER OF GOVT ABRUPTLY SIGNED ORDER FOR IMMEDIATE DEPORTATION ON FOLLOWING DAY (28 DEC) WHICH NOT INCONSISTENT WITH GOB DESIRE FOR OLIVARES VISIT PASS QUIETLY. MARINAS ESCAPED NIGHT 27 DEC AND CAME KIADDRESS FOR HELP.
