 1. HQS REQUESTS WAVE COMMENTS ~~AS FOLLOWS:~~ AS FOLLOWS:

A. CONCUR SANJ TAKE OVER CONTROL AND DIRECTION AMBARBS. TO INSURE STATION CONTROL SANJ SHOULD TAKE OVER ALL FINANCING THUS SEVER ALL DRE TIES.

B. ~~WAVE~~ REALIZE DRE MAY RESIST THIS TREND BUT BELIEVE IN MOST CASES AMBARBS CAN REACH MAXIMUM EFFECTIVENESS UNDER DIRECT STATION CONTROL. ~~WAVE~~ HAVE DRE INSTRUCT AMBARBS COSTA RICA SEPARATE SELVES FROM DRE AND CONDUCT ALL FUTURE ACTIVITIES AS INSTRUCTED BY STATION.

C. HQS DOES NOT WISH STATION TAKE OVER FUNDING OR ATTEMPT CONTROL AMBUD. FROM FIXED MONTHLY BUDGET RECEIVED FROM KUBARK AMBUD-1 PAYS SALARIES AND EXPENSES AMBUD LATIN AMERICAN DELEGATIONS. MATTER SELECTION AND CONTROL THESE DELEGATIONS UNDERSTANDABLY LEFT TO AMBUD-1 THO WE MONITOR THEIR ACTIVITIES AND INTERFERE WITH AMBUD-1 WHEN NECESSARY FOR REASONS SECURITY ETC. BELIEVE YOUR PRESENT CONTACT IDEAL THIS PURPOSE AND TO COORDINATE THEIR EFFORTS WITH OTHER GROUPS.

D. USE KUBARK COMMO CHANNELS SHOULD BE LIMITED TO MESSAGES SPECIAL INTEREST TO US AND WHICH INVOLVE SOME REAL SECURITY HAZARD. DO NOT WISH ATTEMPT HANDLE ALL AMBUD COMMO VIA KUBARK CHANNELS. EXPERIENCE INDICATES THIS BURDENOME AND NOT WORTHWHILE EXCEPT ON DISCRIMINATING BASIS.
