Control No. 183: MARTINES VENEGAS, Emilio.-

According to verbal information received in this Office, apparently this recruit was infiltrated in Cuba before the Invasion of April 17, 1961.

Control No. 445: PEREZ VIVANCOS, Benigno.-

On January 23, 1962 this recruit sent from Cuba a letter in which he designated Alfredo Mateo as the person to receive from him his monthly payment.

According to verbal information received in this Office but unconfirmed, it looks as if Perez Vivancos is moving freely in Cuba, and it is said that he is working now for Castro.

Since the information has not been confirmed and on the other hand, his appointee has not been duly ratified by him, his monthly payments are being deposited in a Saving Account in favor of his family.

Control No. 456: SALICIO SANCHEZ, Francisco.-

According to verbal information received from prisoners returned in December 1962, the last time Salicio Sanchez was seen was during the Invasion at a moment he was wounded and trying to escape into the swamps of Ciénega of Zapata to avoid being made prisoner. We presume that he died afterward.

Control No. 456: FERNANDEZ CARRERA, Francisco.-

In connection with this case we have, more or less, the same information as in the case of Francisco Salicio Sanchez.

His monthly payments are being deposited in a Saving Account in favor of his mother and grand-mother, who are living in Cuba.

Control No. 624: GONZALEZ LEON, Victor Israel.

This recruit disappeared during the actions of the Invasion of Playa Giron. We suppose he might have been drowned during the action of disengaging the bark or killed by the explosions of one of the ships bombarded by Castro.

His monthly payments are being deposited in a Saving account in favor of his mother, Mrs. Ramona Leon, who is in Cuba but we have not been able to obtain her address.

Control No. 2200: SANTOS MOLINA, Mariano.

We have no information as to what has been the fate of this recruit from the time the actions started in Playa Giron. We suppose that he must have been - drowned or killed by the explosions on the ships of the Brigade.
