1. AMRIFT-1 HOLDS POSITION COUNSELOR OF EMBASSY FOR POLITICAL AFFAIRS. BELIEVED TO BE ACTING IN ABSENCE AMB (WHO DEPARTED 25 OCT REPORTEDLY FOR ONE WEEK). PRESENTLY RESIDING IN APARTMENT OF AMSESS-1 (WHO ALSO ON TDY -- HOPEFULLY -- IN PERUMEN). NO KNOWN CONTACT WITH AMPOON-1. WAS IN CONTACT WITH AMSESS-1 PRIOR LATTER'S DEPARTURE, IN FACT THEY LIVED TOGETHER IN APARTMENT. AMRIFT-1 HAS APPEARED IN- FREQUENTLY IN LIENVOY COVERAGE, AND THOSE INSTANCES ARE UNIFORMLY ROUTINE.
