11 June 1963 Meeting:

4. Teresa PROENZA told L-9 that Mirta AGUIRRE, Cuban intellectual, became disgusted with the Consejo Nacional de Cultura and left to teach at the Universidad de Habana. PROENZA said this during a conversation with L-9 re adviseability of working in Cuba. PRCENZA and L-9 both agreed that they would not want to work in Cuba. PRCENZA gave L-9 the idea that she might be going to Paris. (L-9) believes that Coty SOLCRZANO might have brought this word back to PRCENZA from Habana.

6. PROENZA told L-9 that Ramon SINOBAS told Goty SOLORZANO that L-9 was doing a terrific job itc. SINOBAS has been extremely nice to L-9 since his return from Habana.

7. (L-9) said he has noted an obvious coldness on the part of Manuel VECA Perez, Chief Cuban G-2 in Mexico. He said he hardly says hello. L-9 plans to approach VEGA and if he reacts coldly he will ask him what is bothering him.

Additional Notes:

Cn 11 June 63. LITAMIL 9 reported that Ramon SINCRAS Casado, Cuban Charge, (who is very friendly with L-9 since his return), told him to go and see Lic. Ernesto MADERO at the Foreign Office [re Mexican fishing agreements]. on 11 June 1963, Guillermo LNU called Manuel VEGA but L-9 answered the phone. VEGA told (L-9 to tell Guillermo that he had not seen the people yet but planned to see them and to call on 12 June 63. (COPPENT: This one more VEGA contact whose identity is not known.)

16 June 1963 Meeting:

3. On 14 June 63./L-9 told Ramon SINOBAS that Dolores DE LAMORA Cepeda had called him and she wanted to discuss the Architectural Congress with him. SINCBAS told(L-9) not to pay any attention to her This is an interesting comment on the part of SINCBAS, who has taken a liking to 1-9....
