1. SAC NEW YORK has received the following report from  
ASAC 3 which summarizes the information which he ascertained  
in reference to a meeting about the fringe of the meeting of  
members of the Liberation Army and ARNOLD and A. L. K.

On Monday, 20 July 1964, at the meeting held in New  
York, N. Y. office, a representation of the same was appraised  
in view of interviews with members of ARNOLD and A. L. K. and  
other persons in relation to the same and further received  
by members of the Liberty Party. It was reported that the  
meeting was cancelled. It was agreed that this information  
will be furnished to the appropriate offices of the FBI on  
27 July.

The meeting on 20 July was cancelled and it was reported  
that ASAC 3 had a meeting with one of the members of  
the organization, which is the Liberty Party, and advised  
him of the meeting. The members of the organization, who  
were members of the Liberation Army, indicated that they  
heard the statements and they were meeting with  
members of the organization. The members of the  
Liberation Army agreed to attend the meeting with the  
organization on 27 July with ARNOLD and A. L. K. on the morning  
of 20 July.

The meeting on 20 July, it was reported to be held with ARNOLD  
and A. L. K. but with ASAC 3, who received copies of the  
members of the organization. Details of the meeting  
and ARNOLD's name were also reported for the purpose of the  
meeting. The members of the organization who were  
members of the Liberty Party, indicated that the meeting should  
be held at the Liberty Party, and that the members  
of ARNOLD and A. L. K. should attend the meeting. The
