1. SYLVIA TIRADO DE DURAN AKA SYLVIA DE TIRADO, MEXICAN CITIZEN,
WAS EMPLOYED BY CUBAN CONSULATE OFFICE MEXI AS TEMPORARY REPLACEMENT
MARICARMEN LIPARRI UPON LATTER'S DEATH JULY 52. DURAN WAS
DIRECTOR MEXICAN-CUBAN INSTITUTE CULTURAL RELATIONS (INPOC) UNTIL
EARLY JAN 63 WHEN PRESSED BY TERESA FROENZA TO RESIGN. (SEE
MEXI 3035, 9 JAN 63)

2. BEFORE JULY 63, PER LIENVOY, DURAN HAD S. RADIC CONTACT
CUBAN EMBASSY, MAINLY WITH FROENZA RE INPOC MATTERS. FALL 60 HAD
AFFAIR WITH CARLOS LECHUGA. (SEE MEXI 2713, 28 NOV 60 AND HMTA
20549, 4 FEB 63). IN JUNE 62 LICOOKY-1 REPORTED THAT JOSE
REVUELTAS SAID DURAN STRONGLY DRAWN TO HIS LIGA LENINISTA
ESPARTACO, LOCAL DISSIDENT COMMUNIST GROUP.
