MEMORANDUM FOR THE RECORD

SUBJECT: COMMO Logs on Transmittal Times of Cables kept only 90 days;
impossible to find transmittal time of OUT
Teletype 74678 (10 Oct 63)

1. Mr. Echols of COMMO informed me on 23 March that COMMO keeps logs of transmittal times for outgoing cables and teletypes only ninety days. At the end of that time they are destroyed. There is no point, he stated, in trying to find the transmittal times of teletypes sent in October 1963 as such logs have been destroyed by now.

2. It is, therefore, impossible to find the transmittal times of OUT Teletypes 74678 (10 October 1963). Logs containing this information have been destroyed.
