Attached are copies of the FBI memorandum cited in the Jack Anderson columns of 23 and 24 October '78. It was in the Agency in the course of the Church Committee inquiry, for consideration of its sanitization and release to the Committee. Records do not make it clear just what happened at that time. It would assume that it was handled in the confines of that investigation and that the paper did not find its way into other CIA records. We are advised that the four pages comprise the entire memorandum (there are some duplications of the first page that show certain actions (presumably within the Bureau)).

LA Division is now considering the memorandum for possible declassification.
