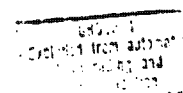
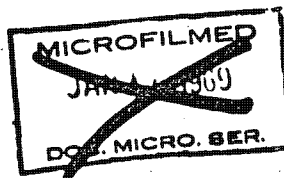

<p>1. Attached are copies of a series of raw reports from LIFTER-8 concerning the "Mexican Committee of Solidarity with Vietnam" (Comite Mexicano De Solidaridad Con Vietnam). It is partially responsive to the requests contained in Reference A; but as stated by Headquarters, some of the information, particularly that dealing with the international aspects of the "Comite" and the "society of journalists," is somewhat sensitive and, therefore, will take time for LIFTER-8 to elicit from Luis SUAREZ Lopez.</p> <p>2. In direct answer to Reference A, Paragraph 1, the "him" refers to HUNY VAN BA. Concerning Paragraph 4, "David" is the Station's operational pseudonym for LIFTER-8. While LIFTER-8 is not a member of the Vietnamese Solidarity Committee, as seen from the attached report, he has numerous contacts who are members.</p>
