2. [REDACTED] TOLD [REDACTED] LETTER DATED 1 SEPT WRITTEN BY A FOREIGN LADY FRIEND IN BRUSSELS. ACCORDING TO [REDACTED] LADY ASKED HIM WHETHER HE HAD CONTACTS WITH [REDACTED] IN ORDER TRANSMIT IN STRICT CONFIDENCE FRIENDLY CRITICISM FROM HER FRIEND, A SOVIET OFFICIAL WHO MUST REMAIN ANONYMOUS. AFTER ASSURING HER HE ABLE TRANSMIT CRITICISM, [REDACTED] RECEIVED ABOVE UNSIGNED LETTER WRITTEN IN PERFECT ENGLISH. WRITER INSISTS HER NAME NOT BE MENTIONED.

3. FROM INTERCEPTS WHICH INDICATE RELATIONSHIP BETWEEN [REDACTED] AND IDEN A, BELIEVE POSSIBLE WRITER IS IDEN-A ABOUT WHOM YOU HAVE INFO. IN CONTEXT RELATIONS: IDEN B, PROVOCATION APPEARS POSSIBILITY.

4. MATTER SENSITIVE AS IMPORTANT NOT DIVULGE [REDACTED] CONNECTION.
