| <p>1. Following [REDACTED] recent visit, the Station had a much better idea of MHCHAOS activities. This dispatch is a round-up of our most recent actions against this target.</p> <p>2. In a meeting with KRHOLLY/8 on 17 December, in addition to the routine discussion and passage of information on the Soviet Bloc people, [REDACTED] presented KRHOLLY/8 with a memo (based on Headquarters 776) requesting information on and [REDACTED] of the MHCHAOS group who were destined for Africa and were likely to visit Lagos. This was given after [REDACTED] had briefed KRHOLLY/8 on the [REDACTED] [REDACTED] indicating the advocacy of violence of each group and the need for us to keep track of their external movements to enable us to protect the stability of our country as he was trying to do in his. [REDACTED] approached him then on the possibility of [REDACTED] [REDACTED] KRHOLLY/8 said that this would be a difficult problem because many US people picked up visas in other countries such as Italy, France, Ghana, etc. [REDACTED] then asked if he could, at a minimum, push for the compilation of [REDACTED] just as he did with the Soviets, since in some cases the [REDACTED] could present a threat to his country as well as our own and that by compiling such travel data and monitoring their activities centrally, perhaps we would both benefit from the effort. He seemed agreeable and said he would attempt to do what he could personally and would bring this up with his hierarchy.</p> <p>3. While KRHOLLY/8 was still motivated with this theme, [REDACTED] mentioned that many of the so-called [REDACTED] were in reality "Communist Agents" and were working for Communism and not for the Civil Rights Movement. We then cited the case of <u>JULIA WRIGHT HERVE</u> and told KRHOLLY/8 that she had been living at the Nigerian Institute for International Affairs; working for the Ministry of Information on Ikoyi and also from the main office; but that she and her husband (who were ostensibly working to help the Nigerians and</p> <p style="text-align: right;">Continued...</p> | | |

working with them via Sam IKOKU and the Ministry of Information) were known members of the "Curiel Apparat" and were using Nigeria, [redacted] and any other group or person, such as NKRUMAH, to further their Communistic goals and that he would be well advised to look into the activities of these people and contacts, since they were undoubtedly involved in subversion and using their jobs and assistance to the FMG as a cover for their real aims. KRHOLLY/8 was aroused and said that he would definitely get onto this matter. He then volunteered that a "Carmichael" had been in Lagos a few months ago and, upon questioning, he said he didn't know if it was "Stokely" or his brother. [redacted] then told him that this was a case in point and that if he had any system of monitoring these people he could help us run down known criminals, just as we would help them run down any criminals that landed in our country.

4. As noted above, KRHOLLY/8 seemed eager and willing to assist, but it is dubious that he will be able to make any real progress on his own or convince his superiors to make a concerted and formal effort to provide us with the information we would like to have, especially the follow-up locally of the activities of MECHAOS people when they arrive and start moving around town. However, the initial reaction was positive and perhaps if we keep plugging away, we can make a break-through in this area.

5. [redacted] reported that the Nigerian Charge' in Algiers had been involved with MECHAOS target personalities. Our records indicate the Charge' at the present time is: James Duro Olufemi SOKOYA; born 1933 at Ojowo, Iebu-Igbo; one of ten Nigerians to attend a course for diplomats (International law and French lessons) in Geneva, based on a bilateral program for technical assistance. SOKOYA was Assistant Chief of Protocol before his present assignment and, according to the LNCUFF Assistant Political Officer, was very friendly and helpful to LNCUFF.
