1. ACCORDING LIFEAT/MKIRAP TERESA PROENZA VISITED APARICIO ON 25 MARCH 1964.

TRANSCRIBER UNABLE RECORD LARGE PORTIONS OF "WHISPERED" AND "CONFIDENTIAL" CONVERSATION (TRANSCRIBER OF COURSE UNWITTING EXTREME INTEREST THIS CASE). MEXI POUCHING PRIORITY COPY OF TAPE IN EXPECTATION HQS WILL WISH REVIEW CAREFULLY, POSSIBLY AFTER TECHNICAL REDUCTION OF EXTRANEIOUS SOUNDS.

2. FOLLOWING SIGNIFICANT ITEMS CAUGHT BY TRANSCRIBER: TERESA SAYS SHE BRINGS MESSAGE FROM MARINELLO. TELLS APARICIO ABOUT VISITING PALACE AND MENTIONS "OSVALDO" (DORTICOS?). APARICIO ASKS: "SO THEN, WHAT ARE YOU GOING TO DO?" TERESA EXPLAINS HOW WELL EVERYONE TREATED HER, ESPECIALLY "LA CASA DE LAS AMERICAS". APARICIO: "I THOUGHT YOU WERE GOING TO WORK WITH JOSE ANTONIO...". TERESA SAYS SHE RECEIVED LETTER FROM HIM, PROMISING HER THAT EITHER IN JANUARY, FEBRUARY, JULY, MARCH OR SEPTEMBER HE WOULD "GET HER" THAT THERE'S A PLACE FOR ME AT THE UNIVERSITY WHETHER I WANT TO BEACH OR NOT". TERESA ADDS SHE'S A LITTLE TIRED OF TEACHING, BUT SHE WOULD LIKE TO WORK ON INTERNATIONAL AFFAIRS.

3. THEN TERESA SEEMS TO BE TELLING APARICIO ALL SHE HAD TO GO THROUGH IN CUBA AND THAT SHE TOLD THEM SHE WANTED TO COME BACK TO MEXICO EVEN IF SHE WAS NOT COMING BACK TO THE EMBASSY. REST OF CONVERSATION SEEMS VERY CONFUSING THEN TERESA COMMENTS "THEY MAKE SO MANY BLUNDERS".

4. APARICIO SAYS "I DID NOT KNOW YOU WERE COMING BACK, I SHOULD HAVE BEEN ADVISED FROM HAVANA". (SEE MEXI 3808 WHICH IS [LITAM IL-7] REPORT THAT EMBASSY HAD BEEN ADVISED OF HER RETURN).

5. TERESA THEN HEARD SAYING SOMETHING IN VERY LOW VOICE AND THEN SHE "SAYS SHE'S FURIOUS ABOUT THE THINGS THEY SAID WHICH ARE NOT TRUE". THEN TERESA MENTIONS SOMETHING ABOUT A LETTER BUT TALKS IN VERY LOW VOICE AND CANNOT BE UNDERSTOOD".

6. TRANSCRIBER'S FINAL COMMENT: "WHETHER BECAUSE OF DEFECTIVE SOUND OR TERESA'S BAD DICTION, UNFORTUNATELY REST OF CONVERSATION NOT HEARD CLEARLY AND IMPOSSIBLE TO TRANSCRIBE, ALTHOUGH NO DOUBT SHE HAS TOLD APARICIO MANY INTERESTING THINGS, JUDGING FROM WORDS HEARD HERE AND THERE THROUGHOUT THE CONVERSATION".

7. STATION WILL FORWARD ANY [LITAM IL-9] COMMENTS RE ABOVE VISIT AFTER MEETING SCHEDULED NIGHT 1 APRIL.
