1. SUBJECT IS SUSAN F R A N K (201-191098), AKA SUSAN MILDRED W A R R E N, AKA LISA A R M A N D, AKA MRS. RICHARD C. F R A N K, NEE: H E I L I G M A N. SUBJECT, BORN 8 NOV 13, NEW YORK CITY, PP #A-1652150, IS MARRIED TO RICHARD CYRIL F R A N K, BORN 22 AUG 22, ROCHESTER, NEW YORK, PP #B-1942048.

2. SUBJECT IS FREQUENT PRC TRAVELER (SEE AMCONSUL HONG KONG 5492, 19 AUG 71) AND HAS HAD NUMEROUS CONTACTS WITH CHICOMS IN PAST. SHE HAS BEEN CHARACTERIZED AS THE "CHINESE PAYMASTER" IN THE U.S. AND HAS BEEN ASSOCIATED WITH THE PROGRESSIVE LABOR PARTY. MOST RECENTLY, SHE INVOLVED IN FORMATION OF U.S.-CHINA PEOPLE'S FRIENDSHIP ASSOCIATION.

3. SENSITIVE SOURCE REPORTS THAT SUBJECT EXITED CHINA VIA HONG KONG ON 31 OCT 71 AND PLANS TO REMAIN IN HONG KONG FOR SOME TIME. (COMMENT: HER HUSBAND EXITED PRC VIA HONG KONG ON 22 OCT 71 FOR UNKNOWN DESTINATION.)
