BRIEFER SHOULD CONTINUALLY STRESS THAT ALTHOUGH BETIDE WILL BE LIVING AND WORKING UNDER ADVERSE CONDITIONS, HIS PRIMARY TASK IS HIS INTELL ASSIGNMENT AS OPPOSED TO HIS M/N INDUSTRY JOB WHICH MUST BE CONSIDERED A COVER JOB.
