4. STATION RECOMMENDS AGAINST SUGGESTED AUDIO CP FOR [REDACTED]

A. DO NOT BELIEVE TAKE WOULD WARRANT EXPENDITURE WORTH TIME AND JOINT ACTIVITY WITH [SMOTH].

D. DESPITE FACT HAVE PCA OF [REDACTED] RECENT ASSIGNMENTS FROM SUBJ DIR 77000 AND TO LESSER EXTENT FROM CEBU INDICATE IS [REDACTED] INTERESTED IN MAKING MONEY, WOULD VERY PROBABLY NOT WANT TO RISK COOPERATION UNLESS BEN OFFERED CONSIDERABLE. WORTH NOTING THAT CP FOR BUILDINGS OWNED BY [REDACTED] ALL HAVE AT LEAST ONE IF NOT MORE OFFICIAL, POLISH FACILITIES OR CHICCO GROUP LEVING THEREIN.
