3. [S] LAYCOCK-1 SHOULD NOT BE BELIEVED RE ARRANGEMENTS FOR  
PACKAGE LAUNCH MATERIALS, AND IF TONIC ARISING SHOULD REFER SUBJECT TO LATER  
DISCUSSION WITH PEPRIDE CO. DETAILS FOLLOW THROUGH KUDRUS/D CHANNELS.

4. ALTHOUGH RECOMMENDED STRONGLY PREFERRED, IF DETENTION ONLY  
ALTERNATIVE, STATION CANNOT GUARANTEE SUBJECT PEPRIDE RESIDENCE STATUS BUT CAN  
ASSIST PEPRIDE ENTRY AS PAROLEE IN WHICH CASE KUDRUS RESPONSIBLE FOR HIM.  
TONE IF HIS PERFORMANCE AND VERIFICATION BONA FIDES AFTER SECRET WARRANT,  
HE MIGHT SECURE RETURN HOME AND ESPECIALLY CITIZENSHIP. KUDRUS NOT ABLE  
GUARANTEE REDEVELOPMENT COURSE PEPRIDE. FROM ANY TONIC PEPRIDE LAUNCHER  
STRONGLY RECOMMENDED.

5. IF SUBJECT RECORDED IN PLACE AND WILL RETURN TO CUBA, HQS WILL CABLE
