1. REQUEST STATION OBSERVE AND ADVISE HQS IMMEDIATE ARRIVAL MEXI AMSWEEP-1 (IDEN A), HQS SW REPORTING ASSET, SCHEDULED ARRIVE MEXI 4 NOV CUBANA FLIGHT FROM HAVANA. TRAVELLING WITH WIFE (IDEN B).
2. STATION NEED NOT CONTACT UNLESS AMSWEEP-1 AND WIFE ENCOUNTER DIFFICULTIES. BOTH HAVE VALID U.S. VISAS. EXPECTED PROCEED DIRECTLY NEW YORK WHERE TWO SONS RESIDE. SONS CURRENTLY IN DIRECT CONTACT WITH HQS. IN EVENT STATION CONTACT NECESSARY HQS CASE OFFICER ALIAS, JOHN (JUAN) BRITHEKIN CAN BE USED ESTABLISH BONAFIDES.
